## Man faces charges of sex offense with child from Cary, Raleigh police

RALEIGH — Jose Alfredo Cruz Jr. was charged Monday with two counts of first-degree sex offense with a child in Cary, and Raleigh police added another count Tuesday morning.

Cary police charged Cruz, 26, of 1913 Pinetuck Court in Cary had been <u>involved with a 9-year-old</u> on Sunday.

Their arrest warrants for first-degree sex offense with a child did not divulge the child's gender.

While Cruz was being held on \$200,000 bail for a Tuesday court appearance, Raleigh police served a warrant charging first-degree sex offense with a child on Jan. 1.

Cruz's bail was raised to \$700,000.

## Man tried to kidnap child in Durham

DURHAM, N.C. (WTVD) -- The Durham Police Department has arrested a man after he allegedly tried to drag a girl into his home.

It happened around 2 p.m. on Tuesday.

Investigators said 28-year-old **Alfredo Contreras-Palacio** approached the child playing outside and offered her money to come into his home.

When she refused, he allegedly grabbed her by the wrist and shoulder and started to pull her towards his home.

Two other children ran after Contreras-Palacio and stomped on his feet and pulled the girl to safety.

Contreras-Palacio is charged with <u>second-degree kidnapping and taking indecent liberties with a child</u>. He was placed in Durham County Jail under a \$500,000 bond.

## Hoke County man facing sex charge

RAEFORD, N.C. (WTVD) -- The Hoke County Sheriff's Office has charged a man with <u>indecent liberties with</u> a child.

Deputies said 19-year-old **Jose Ortiz** sexually assaulted a juvenile in the Lafayette Woods Mobile Home Park, and they say there could be more victims.

Authorities said Ortiz and the victim had known each other for just about two months leading up to the alleged incident.

The investigation continues and more charges could be filed.

Bond was set at \$20,000.

## Raeford man charged with taking indecent liberties with a child

**Jose Armando Ortiz**, 19, of the 200 block of Lafayette Woods Mobile Home Park, was charged Tuesday with taking indecent liberties with a child.

Ortiz was acquainted with the victim, whose age was not given, a Sheriff's Office news release said.

Investigators are trying to determine whether there are other juvenile victims, the release said.

Bail was set at \$20,000.

## Lincoln Co. man charged with sex crimes against 11-year-old

A western Lincoln County man was charged with child sexual assault charges against a child he knew.

**Ricardo Miguel Magallanes**, 32, of Lincolnton was arrested on Friday on <u>two felony counts of First Degree Sexual Offense</u>, according to the Lincoln County Sheriff's Office.

Lincoln County Department of Social Services notified the Sheriff's Office about the incidents which occurred last week at the home of the 11 year old female victim.

Magallanes is a friend of the family.

The investigation is ongoing and additional charges are expected to be filed.

Magallanes is being held in the Harven A. Crouse Detention Center under a \$250,000 secured bond.

## Apex man charged with taking indecent liberties w/7 year old

APEX — An Apex man is facing charges of taking indecent liberties with a 7-year-old almost four years ago.

Police arrested **Joel Perez Ramirez**, 23, of 1001 Seagram St. on a warrant taken out by Wake County sheriff's deputies.

The warrant alleges two counts of taking indecent liberties with a child and says it happened during the summer of 2010, between June 1 and Sept. 30.

The child was 7 years old and turned 8 during that time, the warrant indicates.

Ramirez was being held on \$100,000 bail for a court appearance Wednesday.

## Ex-teacher faces 56 counts in sex assault, peeping case

MEBANE — A former Randolph County Schools teacher who faces <u>56 charges</u> in connection with sexual contact with or illegal photography of students turned himself in to deputies today, according to a news release.

In December, deputies charged **Hazem Moustafa Eldara**, 54, of 350 Stowe Ave., in Asheboro, with taking indecent liberties with a student. Eldara posted bail and was released.

Further investigation led to authorities on Feb. 3 to charge Eldara with 19 more counts of taking indecent liberties with a student, 18 counts of using a photographic imaging device to view others and 18 charges of possession of a photographic image obtained in violation of secret peeping statute, according to a news release. The continuing investigation led deputies to seize several digital media devices, according to the news release.

Searches of the devices helped deputies identify seven more victims, according to the sheriff's office. All but one are current or former students of Eldara, who taught math to students in the ninth through 12th grades. The eighth victim is an adult who worked at Randleman High School with Eldara, deputies said.

Deputies did not arrest Eldara earlier because they <u>thought he had left the country</u>, according to the release. Eldara is being held on \$2.75 million bail at the Randolph County jail.

## 40 arrested; 25 brothels in N.C. found following 5-year investigation

A tip nearly five years ago led to the <u>arrests of 40 people</u>, including 30 in Winston-Salem, over the past few years on state and federal <u>charges of human trafficking</u>, <u>prostitution and kidnapping</u>, authorities said Thursday.

In August 2009, a Winston-Salem resident gave investigators a tip about a brothel, said Lt. David Lamb of the Winston-Salem Police Department.

Investigators eventually learned that the brothel was part of an <u>organized prostitution ring that moved women</u> and girls in and out of the state, Lamb said.

An undercover police detective who worked on the case said that the victims paid to be smuggled into the U.S. and were told that they would get legitimate jobs here. When they arrived, though, they were forced into prostitution, the detective said.

The victims came from Central America, including such countries as Honduras and Guatemala, the detective said. A minor was among the victims.

Investigators identified 25 brothels in North Carolina, nine of which were in Winston-Salem. The brothels were scattered around the city, including in the Robinhood Road area, the Thomasville Road area, the Easton neighborhood and off University Parkway and Shattalon Drive, police said.

The suspects face a total of <u>76 charges at both the state and federal levels</u>. Several law enforcement agencies contributed to the investigation, including police in Asheboro, Durham, Greensboro, Raleigh and Kernersville.

Vincent Picard, a spokesman for U.S. Immigration and Customs Enforcement, said his agency focuses on stopping human exploitation, including sex trafficking and prostitution.

"We are concerned about women being in trafficking against their will," Picard said. "No one agency can address a problem like this by itself."

City police identified one Greensboro resident and six Winston-Salem residents who had key roles in the prostitution ring.

These defendants have been through the court process:

• Carmina Canton, 55, of 1825 Boulevard St., Greensboro, was charged last January with soliciting prostitution and maintaining a dwelling for prostitution in March 2012.

Canton was convicted of the charges last month in Forsyth District Court. A judge gave Canton a suspended 45-day jail sentence and put her on probation for 18 months, a court record shows. She was ordered to pay \$530 in fines and court costs and spend two days in the Forsyth County Jail.

• **Deysi Suyapa Rodriguez**, 39, was charged in January 2011 with felony sexual servitude and promoting prostitution of a minor, an arrest warrant says.

Rodriguez served 20 months in prison after she pleaded guilty to promoting the prostitution of a minor in August 2011 in Forsyth Superior Court, according to court and state correction records.

• Fredi Menendes Garcia, 43, was charged in June 2011 with promoting prostitution of a minor and maintaining a dwelling for prostitution, an arrest warrant says.

Garcia served 14 months in prison after he pleaded guilty to both charges in March 2012, according to court and state correction records.

- Mauro Aparicio Hernandez, 51, and Augusto Justino Valverde-Morales, 52, each were charged in December 2010 with felony human trafficking and kidnapping, both state offenses, and importation of an alien for an immoral purpose, a federal offense, police said.
- Augusto Justino Valverde-Morales, 51, of 1438 N Cherry St., Winston-Salem importation of alien for immoral purpose, human trafficking and kidnapping.

Hernandez and Valverde-Morales were accused of holding a woman in involuntary servitude or sexual servitude and moving that woman from place to place without her consent, arrest warrants say. The woman was sexually assaulted, according to the warrants.

Assistant District Attorney Lizmar Bosques dismissed the charges against Hernandez and Valverde-Morales in May 2011 because the federal government planned to prosecute the men. The status of their federal cases was unavailable Thursday.

- Lorenzo Espinal Almonte, 34, was charged with interstate commerce to facilitate prostitution, a federal offense, police said. A U.S. attorney dismissed the charge, Picard said.
- Ondina Lizeht Alonso Hernandez, 32, of Southwin Drive was charged with human trafficking, a federal offense, Picard said. The status of her case was unavailable Thursday. The following law Enforcement Agencies contributed to the investigation:

## Two men charged in Cary laundromat murder

CARY — Police have charged two men with murdering another man in a Cary laundromat late last month.

Authorities arrested **Rumaldo Ramirez Velasquez**, 40, of Cary in South Carolina last Friday, the town announced Tuesday. Police have issued a warrant for the arrest of **Ruben Gilberto Hernandez**, 23, also of Cary.

#### Both are charged with murder.

A cleaning person found the body of Eriberto Cresencio Bosques lying face down in the Wash Tub Laundromat at 101-E Reed St. on the morning of March 29, according to police. The State Medical Examiner's Office ruled the death a homicide, but Cary police haven't said how Bosques, 29, died.

In a written release, Capt. Don Hamilton congratulated the town's detectives and its investigative partners, but he said the case remained "a very active investigation." The release asked anyone with further information to contact Cary police at 919-469-4012 or file an anonymous report via Cary CrimeStoppers at 919-460-4636.

CrimeStopperes pays for helpful tips on open criminal cases.

Hamilton declined to comment on the suspected motives in the case.

## Man arrested in fatal Randolph County stabbing

RANDLEMAN, N.C. — Randolph County deputies say a 21-year-old man wanted in a stabbing death was arrested while trying to board a plane to Mexico.

Authorities said a friend found 43-year-old Eduarrdo Hurtado suffering from several stab wounds in his home around 10:30 p.m. Saturday.

Deputies say they identified **Edgar Ramirez** as a suspect in the killing, and arrested him at the Piedmont Triad International Airport as he tried to get on a plane.

Authorities did not say what linked him to the slaying or give a motive for the stabbing.

Investigators say Hurtado had been dead for several hours before his body was found.

## Arrest made in Capital Boulevard fatal hit-and-run

RALEIGH (WTVD) -- Raleigh police have made an arrest in a fatal hit-and-run pedestrian accident on Capital Boulevard.

Thursday morning, officers manning a traffic checkpoint in the northbound lanes of the 2900 block of Capital Boulevard noticed a Lexus sedan.

After investigating, they charged its driver, 55-year-old **Ghassan Alsabbagh**, of Raleigh, with <u>felony hit-and-run</u>.

Alsabbagh was taken into custody in Louisburg. He was then taken to the Wake County Detention Center.

Sixty-four-year-old Cornelia Amissah was killed on Capital Boulevard around 7 a.m. on March 20.

Investigators said it appears Amissah was struck by multiple vehicles, only one of which remained at the scene.

## Teen shooter sentenced in fatal Durham carjacking

DURHAM — The third teenager charged in a 2012 carjacking and murder in Durham was sentenced to 29 to 38 years in prison Thursday for shooting a man so he and two friends could steal his SUV.

**Justino Navaretta Maya**, 17, pleaded guilty to second-degree murder in the Dec. 28, 2012 death of Johnny Danilo Villatoro, 35, the father of three.

He also pleaded guilty to robbery with a dangerous weapon and conspiracy to commit robbery with a dangerous weapon.

As a condition of his plea bargain, Maya <u>also pleaded guilty to a breaking and entering and larceny in Orange</u> County. At the time Villatoro was killed, Maya was on pretrial release for those charges.

Sitting beside his attorney, Fred Williams, Maya answered questions from Superior Court Judge Elaine Bushfan in a quiet voice, showing no emotion. In contrast, one of Villatoro's three siblings in the courtroom sat with his face in his hands and made occasional sobs.

"Why couldn't (the killers) think that he had a family that needed him?" Jose Villatoro said, speaking in Spanish with a court interpreter. "He was trying to do a good thing and ended up bad."

Maya was <u>accused of shooting Villatoro seven times</u>, <u>including shots fired from above when Villatoro was lying on his back</u>, according to prosecutor Jim Dornfried.

One of the other teens, Diana Escobar, who was 14 at the time of the crime, pleaded guilty in March to the same charges as Maya and will spend 10 to 13 years in prison. Her sentencing is scheduled in May.

The third, 12 at the time of the killing, has already pleaded guilty to first-degree murder in juvenile court. She is being held in a juvenile-detention facility until she is 21, he said. Police do not release the names of juvenile defendants.

According to Dornfried's account, the 12-year-old was the instigator of the crime. About a week before Villatoro's death, she had run away from home in Raleigh and came to stay in a Durham apartment on Channing Court in Bragtown, off North Roxboro Street.

There, she met Maya and the two became romantically involved, Dornfried said. On Dec. 28, they and Escobar discussed doing a drive-by shooting of an unspecified gang. Since they had no vehicle, they planned to carjack one and kill the driver.

They encountered Villatoro at a cellphone store where he had gone to pay his bill and asked him for a ride home. He agreed, and they directed him to a dark cul-de-sac where Maya, pulling a handgun a vacationing neighbor had left him for safekeeping, ordered Villatoro out of the car.

"It's unclear what occurred," Dornfried said, but it appears that Villatoro scuffled with the 12-year-old before he was shot and left lying on the street after Maya drove over his arm.

After returning to Channing Court, he said, Maya and Escobar were unwilling to go through with the drive-by shooting. The 12-year-old took the handgun and accidentally shot herself. Wounded, she called her mother to get an ambulance, but asked her not to call police.

The mother called police anyway and the trio was quickly linked to Villatoro's death.

Villatoro was a native of Honduras who had lived in Durham for 18 years, his brother Francisco said, through the interpreter. He was the oldest of 11 brothers and sisters and the first to move to the United States.

Overnight, police charged **Keren Velasquez** with causing the wreck that killed one of the passengers in her car.

Police said Velasquez lost control of her SUV when she tried to change lanes on Albemarle Road near Mallard Drive around 7:30 p.m. Thursday.

Officers said Karina Velasquez was thrown from the vehicle and died.

Two children who were passengers in the vehicle have minor injuries and police said one of them was not in his car seat properly.

Velasquez faces several charges, including misdemeanor death by vehicle and not having a license.

One person was killed and another injured in a car accident in southwest Charlotte Tuesday evening.

The wreck happened near the intersection of Tryon Street and Tyvola Road in southwest Charlotte around 8:30 p.m.

Police confirmed to WBTV that 39-year-old Ramez Ahmed Shams Eldin, was killed in the crash, and 50-year-old Michael Perrella was taken to an area hospital.

Police say Perrella was speeding and hit Eldin's Jeep from the rear with his Ford Expedition, causing both to spin out of control.

Perrella's vehicle crossed across the northbound lanes and hit a telephone pole. Eldin's Jeep came to rest on the sidewalk

Police say speed and impairment are factors in the crash.

Perrella is charged with driving while impaired and a warrant for felony death by motor vehicle has been issued.

The investigation is ongoing.

## Moore County man, teen accused of breaking into six homes

SOUTHERN PINES - A Moore County man and a 14-year-old juvenile are accused of breaking into six homes, the Southern Pines Police Department said today.

**Eudy Ulloa Blanco,** 21, of the 200 block of West Vermont Avenue in Southern Pines, and the 14-year-old are charged with six counts each of breaking and entering, larceny, conspiracy and obtaining property by false pretense, a police release said.

The 14-year-old, who was not identified because of his age, is being charged through juvenile petitions, the release said

Blanco also is charged with contributing to the delinquency of a minor, the release said.

The break-ins were reported between Feb. 24 and March 7, according to the Moore County Sheriff's Office website.

Blanco's bail was set at \$85,000.

The juvenile is being processed through the Juvenile Justice System, the release said.

## Nigerian Drug Dealer sentenced to 263 years on drug and gun

GREENVILLE - A Johnston County man was sentenced to roughly 263 years on drug and gun convictions in U.S. District Court on Thursday.

**Felix A. Okafor**, 53, (a US based Nigerian storeowner) of Benson, was <u>convicted last summer of 25 offenses</u>, <u>including drug trafficking</u>, <u>conspiracy and distributing drugs near a school</u>, according to a news release.

Senior United States District Court Judge Malcom J. Howard sentenced Okafor on Thursday.

In November 2012, Okafor sold marijuana and heroin to a confidential informant at Okafor's convenience store, the Flying Eagle, in Benson, prosecutors said. Okafor had a gun with him on each of the exchanges, the release said.

The store was within 1000 feet of Benson Middle School.

In the release, prosecutors said Okafor also used the store as a haven for cutting and packaging drugs for sell. Okafor was convicted after a four-day trial in July 2013.

Investigators from the Bureau of Alcohol, Tobacco, Firearms and Explosives, the North Carolina State Bureau of Investigation, the Johnston County Sheriff's Office and North Carolina Alcohol Law Enforcement were involved in the case.

Assistant United States Attorney Ethan A. Ontjes prosecuted the case.

## Vehicle inspectors sentenced for falsifying emissions tests

A vehicle emissions inspector was sentenced on Thursday to <u>two months in federal prison</u> for his role in a scheme that gave passing scores to more than 200 vehicles that violated pollution limits.

**Pedro Salmeron**, who worked at Charlotte-based Carolina Inspections, is the most recent of 14 people to be sentenced for "clean-scanning" cars and trucks in the Charlotte area. The process involves entering one vehicle's information into a state emissions database, then using another vehicle to conduct the test.

According to court records, Salmeron conducted 201 illegal inspections from February 2010 until January 2011, falsely passing vehicles that would have otherwise failed.

When Salmeron, 37, is released from federal prison he'll have to be supervised by a parole officer. He also must pay a \$5,000 fine and perform 50 hours of community service.

The punishments of the other 13 people sentenced for clean-scanning ranged from probation to 18 months in prison.

In September, **Jose Manuel Cabrera**, who prosecutors said was a **Charlotte gang member** who falsified emissions inspections on 164 cars, was <u>sentenced to a year in federal prison</u>. Authorities say he'd charge \$60 a car for a bogus inspection.

The U.S. Clean Air Act requires that cars in 48 of North Carolina's 100 counties be inspected to make sure they don't exceed federal limits of compounds that are dangerous to breathe. The act prohibits falsifying records.

Inspectors conduct emissions tests by hooking up a car to a machine that checks its computerized emissions system, or on-board diagnostics.

A 2011 investigation by The Charlotte Observer and The (Raleigh) News & Observer found crooked garages have undermined the emissions testing program by faking results, sometimes for bribes.

## 4 charged in connection with gang graffiti

WINSTON-SALEM — Police said four men were charged Tuesday in connection with gang graffiti that was found on a Winston-Salem park a few days earlier.

Charged with injury to real property and violation of the city graffiti ordinance are:

Jose Manuel Campos, 20, of 2720 Cole Rd., Erick Javier Diaz, 16, of 305-7 Polo Rd., Darien Alonso Lopez, 16, 3010 Broadbay Dr. and Luis Antonio Rosado Jr., 22, 1441 N. Cherry St.

The four are accused of spray painting gang graffiti at Easton Park at 3599 Tyler Drive on Friday.

A park ranger found the graffiti on the basketball courts, street signs and several large boulders around the park, causing damage worth more than \$1,000, police said.

Law enforcement classified the incident as a gang-related crime because it was a "furtherance of the gangs," of the <u>Autumn Oaks SurenosGang</u> and <u>Flores 13 Gang</u>, police said.

Campos, Diaz, Lopez and Rosado were each given bail of \$1,000.

## Man arrested after Lee County home break-in

SANFORD, N.C. — Authorities in Lee County arrested a man they say broke into a home on Dover Street in Sanford last week.

**Luis Fernando Moreno**, 20, of Thornwood Drive was arrested and <u>charged with felonious breaking and entering and injury to real property.</u>

According to the Lee County Sheriff's Office, Moreno broke into the home of Cash Jay McDonald just after 9:30 a.m. last Friday.

McDonald was asleep at the time and was awaken by a loud sound. He quickly realized there was a stranger in his home.

"I found the screwdriver inside. He tried to pry the door open," he said. "I could see the shadows coming around the corner"

When McDonald came face to face with Moreno he told him he would shoot him. Moreno then ran out of the home, jumped in his car and tried to get away. Authorities said he did not make it past the driveway before he crashed

"Then there was the second face-to-face meeting," McDonald said. "At the end of a gun, and this time it lasted a whole lot longer."

McDonald said he held Moreno at gunpoint and waiting for authorities to arrive.

"He kept telling me he wanted to get out of the situation and I kept telling him I had a gun," McDonald said.

Deputies showed up at the home and arrested Moreno.

Moreno has since bonded out of jail.

## Police, other agencies wrap 2 month drug investigation

Police say they've wrapped up a two month drug investigation.

As part of the investigation, they've <u>arrested two Mexican nationals</u>, seized 2 1/2 kilograms of cocaine, 330 dosage units of heroin, \$14,739 in U.S. currency, and a 9 mm handgun. The estimated street value of the cocaine is about \$250,000.

Officers say it's all linked to a recent Greenville homicide investigation. Police say it likely that **Gambino Benitez Correa** and **Julio Cesar Avalos Rodriguez** supplied drugs to an apartment on Mulberry Lane, the scene of a December 2013 homicide.

Correa and Avalos-Rodrigues were arrested and charged with numerous conspiracy and cocaine trafficking charges. Correa is incarcerated in the Pitt County Detention Center under a \$2.5 million secured bond. Rodriguez was also charged with numerous conspiracy and cocaine trafficking charges and incarcerated in the Pitt County Detention Center under a \$1 million secured bond.

Officers showed members of the media some of the tactics drug traffickers used. During their investigation, a Greenville Police K-9 led police to an air compressor with a secreted compartment. Inside, agents found 2 kilograms of cocaine.

Police say these investigations were successful due to the partnerships between the Greenville Regional Drug Task Force and the Drug Enforcement Agency (DEA). The Greenville Regional Drug Task Force is composed of Law Enforcement Officers from the Greenville Police Department, Pitt County Sheriff's Office, North Carolina State Bureau of Investigations, Farmville Police Department and the Winterville Police Department.

The Drug Task Force provides an extremely effective network of experienced criminal investigators dedicated to pursuing violators of state and federal controlled substance laws. Leveraging each partner agency's expertise, equipment, manpower, and finances has proven to be a substantial benefit to the citizens of Pitt County and a model of success.

GREENVILLE, N.C. — Authorities say a Raleigh man <u>faces multiple drug charges</u> following a traffic stop in Greenville.

WCTI reports (http://bit.ly/1iGHjvh) the Greenville Police Department said 21-year-old **Faisal Tyler Moghadass** is being held in the Pitt County jail under a \$1.3 million bond. It couldn't be determined if Moghadass has an attorney.

Police said the Greenville Regional Drug Task Force and Drug Enforcement Administration agents stopped Moghadass on April 16 on the city's west side. Moghadass, who was the only person in the vehicle, was arrested on multiple drug charges.

Investigators said 454 grams of the club drug known as "Molly" and two pounds of high-grade marijuana were seized during the traffic stop. A search of Moghadass' home in Raleigh turned up 1,647 grams of "Molly" and about 200 grams of high-grade marijuana.

The Greenville arrest was the latest legal problem for Moghadass.

The News & Observer of Raleigh reported last October that he was arrested along with another man for conspiring to sell marijuana to another man.

According to the newspaper, Raleigh <u>police charged Moghadass last April with marijuana possession with</u> intent to sell or distribute it, possession of cocaine and maintaining a vehicle. Four years ago, he was arrested by

Raleigh police at Millbrook High School and charged with drug offenses, having a weapon on school property and other counts.

After his arrest last April, he was convicted on possession of drug paraphernalia and ordered to enter drug treatment. The drug charges were dismissed by the district attorney's office.

## Va. man pleads guilty in multistate fake ID case

RICHMOND, Va. — A Virginia man pleaded guilty Friday to participating in a sophisticated multistate fake identification ring and plotting to steal a rival document-maker's equipment.

Manuel Garcia-Rojas, 28, of Richmond, <u>pleaded guilty to racketeering and attempted robbery</u> in U.S. District Court. He faces up to 20 years in prison on each count when he is sentenced July 31. Three charges were dropped as part of a plea agreement.

Nine other defendants who were indicted along with Garcia-Rojas late last year are scheduled for trial June 2.

According to prosecutors, Garcia-Rojas was a runner for the Richmond cell of <u>a fake ID enterprise based in Mexico that also had operations in Arkansas, Massachusetts, North Carolina, Ohio and Rhode Island</u>. A runner's job was to solicit illegal immigrants as customers for phony documents, including Social Security cards and green cards. The high-quality, bogus documents typically sold for \$120 to \$250 a set.

The indictment says the ring's U.S. operations were overseen by **Hidalgo Flores**, who instructed cell managers to wire the proceeds to upper management in Mexico. Financial records show that from January 2012 through October 2013, more than \$300,000 was transferred.

The government says ring members used violence to maintain the enterprise. Garcia-Rojas and three codefendants were accused of trying to assault a rival fake ID maker in Richmond and steal his equipment. Prosecutors say a police traffic stop thwarted the scheme.

In court, Garcia-Rojas balked when U.S. Magistrate Judge Hannah Lauck asked if he was pleading guilty because he was, indeed, guilty. Speaking in Spanish through an interpreter, Garcia-Rojas told the judge: "Like I said to my lawyer, I am guilty of conspiracy but not of attempted robbery."

After a brief consultation with his attorney, Garcia-Rojas was asked again if he was guilty of both counts. He replied, "Si."

The indictment says the enterprise began in 2008. Court papers in previous cases show that the ring wired more than \$1 million to Mexico before it was dismantled in late 2010. Twenty-six people pleaded guilty, and one was convicted at trial in the slaying of a rival fake ID seller in Arkansas and was sentenced to two consecutive life terms.

Within two years, prosecutors say, the enterprise restarted under the same leadership in Mexico but with different participants in Richmond; Springdale, Arkansas; Raleigh, North Carolina; Pawtucket, Rhode Island; Cincinnati and Boston.
