A Seven Springs man is in jail, accused in the statutory rape of a relative who is now pregnant.

Wayne County deputies say **Florencio Gomez** was arrested Wednesday on <u>charges of statutory rape and sex</u> <u>offense with a defendant at least six years older than the victim.</u>

Deputies say they were alerted Tuesday to the sexual assault of a 14-year-old girl after she went to a doctor's office and discovered she was pregnant.

The 26-year-old Gomez has been jailed in a \$500,000 bond.

# Charlotte minister charged in child sexual assaults

Charlotte-Mecklenburg police have charged a 64-year-old minister at Memorial United Methodist Church on Central Avenue with taking indecent liberties against girls ages 6 and 10.

Police arrested **Orlando Agusto Caldera** on two counts of indecent liberties against a child after responding to a call of a disturbance shortly before 9 p.m. Monday at the church, which is at 4012 Central Ave.

Arriving officers met with the victims and one of the girls' mothers. Police said they reported that Caldera had inappropriately touched the girls.

Officers said they spoke with Caldera, who then agreed to be transported to police headquarters, where Youth Crimes detectives interviewed him. He was taken to the Mecklenburg County Sheriff's Office, where he remained in custody Tuesday afternoon.

Detectives were able to identify five additional female victims that had been sexually assaulted by Caldera on Wednesday. The victims were between the ages of 6 and 10 years of age and there are now 26 additional charges.

RALEIGH — A Raleigh man is facing charges of child rape and taking indecent liberties with a girl who was under 13 from 2002 through 2004.

**Rafael Jahuey Cazuela**, 34, was arrested Monday night after detectives who investigate sex crimes brought him to their downtown Raleigh office.

In an arrest warrant, Cazuela has an address on Rolling Green Court, but he gave booking officers at the Wake County Detention Center an address of 5111 New Hope Road.

The warrants charges one count of each offense and says they happened between Jan. 1, 2002, and Dec. 31, 2004.

Cazuela was being held in lieu of \$500,000 bail for a court appearance Tuesday, and federal immigration officials asked that he be held for 48 hours while they check his immigration status.

Cazuela is a Mexican native, officials said.

# Man indicted on 24 sex charges

A 42-year-old Onslow County man was indicted by a grand jury on Wednesday on eight counts of indecent liberties with a child.

**Apolonio Venegas-Benavides**, of Beulaville Highway in Richlands, is accused of attempting indecent behavior with a girl who was under the age of 16 at the time, according to warrants.

Warrants state that the indictment stemmed from incidents that happened between September 2004 and 2005.

Bond was set at \$70,000.

He was charged in October 2012 with nearly 20 sex crimes alleging years of child sexual assaults.

Venegas-Benavides was charged by the Onslow County Sheriff's Office with 11 charges of indecent liberties with a child, five charges of first degree sex offense with a child, three charges each of crime against nature and statutory rape/sex offense with the defendant 6 or more years older than the alleged victim and two charges of felony child abuse through sexual act.

He was accused of engaging in sex acts with two different girls on multiple occasions, when one of the girls was 10, 13 and 14, and with another girl when she was 9 and again when she was 10, according to warrants.

The offenses allegedly occurred from September 2002 to September 2009, according to warrants.
