GRAHAM — A man originally charged with kidnapping and raping his wife pleaded guilty Thursday to lesser charges of sexual battery and felonious restraint.

Jose Manuel Quintanilla, 37, of Georgia Avenue in Burlington, entered a guilty plea via the Alford decision on Thursday. An Alford plea allows a defendant to enter into a plea agreement without admitting guilt to the facts of a case.

The state argued that the man was guilty of the crimes but that the victim in the case was difficult to work with. The defense argued that **false charges were brought against Quintanilla to help the woman obtain a special type of visa from U.S. Immigration and Customs Enforcement.**

Burlington police charged Quintanilla with first-degree kidnapping, second-degree rape and assault in April. Quintanilla was also originally charged with kidnapping the couple's four children. Those kidnapping charges

were dismissed because a parent can't be charged with kidnapping their children if a judge hasn't issued a custody order, said Alamance County Assistant District Attorney Lori Wickline.

Wickline said the state agreed to a plea because Quintanilla, who is under a Federal ICE detainer, will likely be deported. If he ever re-enters the U.S., he will have to register as a sex offender on the sexual battery charge. The victim in the case was also difficult to locate and work with, Wickline said. The phone numbers she gave Wickline are no longer working and she has moved out of Alamance County.

The plea also spared the couple's children from having to take the stand and testify against their father.

"I feel very good about the outcome in this case," Wickline said.

Defense attorney David Remington argued that the charges against Quintanilla were false.

Quintanilla caught his wife having an affair, Remington said. When he threatened to leave with their children, she brought the charges. Also, a fairly new type of visa, called a "U Visa," allows immigrant victims of crime and their families to petition for green cards.

"He stated from the beginning, and he never waived on this, that she brought these charges to get a visa," Remington said. "I didn't know about (U Visas) until I started asking around in this case, but they are fairly well known in that community."

Burlington teen charged in apartment fire

Illegal alien busted with 3,500 grams of cocaine, deputies say

SALISBURY - A Union County man has been arrested after deputies say he was hauling more than 3,500 grams of cocaine through Rowan County.

According to the Rowan County Sheriff's Office, the Special Investigations Unit received information that a large shipment of cocaine was to be delivered to the Salisbury area of Rowan County, by a Hispanic male.

Investigators from the Rowan Sheriff's Office and Salisbury Police conducted the investigation, and say they identified Luis Valencia, as the suspect involved in the Cocaine delivery.

32-year-old **Luis Valencia**, who was located traveling into Salisbury, was stopped and investigators located **3 and a half Kilograms (3,500 Grams) of cocaine** after searching the vehicle. Valencia was arrested, and his bond was set at \$ 400,000.

ICE Agents determined Valencia was in the U.S. illegally.

Investigators located Valencia's residence in Wingate NC. Union County Sheriff's Office conducted a search of this residence and located two firearms, with one reported stolen.

A Gaston County man has died following a shooting at his home around 1 a.m. Saturday.

Enrique Rafael Alvarez, 36, of 2440 Myers St., Gastonia, died at Gaston Memorial Hospital after being shot at his home.

Police are still searching for the shooting suspect. They say the circumstances around the shooting are being investigated.

ASHEVILLE — More details emerged Wednesday in an immigration raid that led to the detention of 12 restaurant workers, including the nationalities of some and how many remain in custody.

A representative of Shogun Buffet Hibachi Grill & Sushi also commented for the first time since the Dec. 1 arrests made at the restaurant at 1000 Brevard Road south of Asheville.

Nine of workers have each posted a \$2,000 bond and been released from the Henderson County jail, said Loida Ginocchio-Silva with the local immigrants' rights group Defensa Comunitaria.

Four are from El Salvador, two are from Mexico, one is from Guatemala and two are from one or more unidentified Asian countries, Ginocchio-Silva said.

Of the three denied bond, **one is Salvadorian and two are Asian**, she said.

Federal prosecutors said Jorge Peter Cornell, 35, of Greensboro led the North Carolina chapters of the Almighty Latin King and Queen Nation, a criminal gang based in Chicago and New York. Prosecutors said Cornell, also known as "King Jay," became a Latin King when he lived in New York. He took the title of "Inca," or leader, when he moved to North Carolina.

Six alleged members of the gang, including Cornell, who were arrested today attended their initial appearance held in a federal courtroom in Greensboro.

The other five defendants included Samuel Isaac "King Hype" Velasquez, 22; Russell Lloyd "King Peaceful" Kilfoil, 25; Charles Lawrence "King Toasty" Moore, 26; Richard Lee "King Focus" Robinson, 22; and Luis Alberto "King Speechless" Rosa, 24.

U.S. Magistrate Judge P. Trevor Sharp read the six men their rights, appointed each man his own attorney and set their detention hearings for next Tuesday. The six men remain in custody.

According to the indictment, Latin King members in North Carolina have taken part in numerous criminal activities, including assault, robbery, bank fraud, extortion and murder, since 2005.

Cornell and other alleged gang members are accused of 36 specific criminal acts, according to the indictment. Among them:

- **In July 2010, Cornell bragged of killing a member of the rival MS-13 gang. It is unclear when or if the slaying took place.**
- **In December 2009, Cornell ordered gang members to use machetes to kill three other unidentified gang members who had rebelled against Cornell's rule.** Five months later, Cornell ordered gang members to firebomb a house of a disgruntled Latin Kings member. The indictment does not say if either attack was carried out.
- Four gang members assaulted a former Latin King member outside the Guilford County courthouse in October 2010. The attack was in retribution for the man leaving the gang.

- In October 2009, Cornell ordered a gang member to burn down the house of the grandmother of another gang member so Cornell could collect part of the insurance proceeds. Cornell later stole a government electronics benefit card from a gang member who refused to commit arson. The house was burned in July 2010, and Cornell and another gang member collected insurance money.

Federal prosecutors said Cornell also led a public relations campaign to disguise the gang's activities and frustrate police officers. That campaign, prosecutors said, included an attempt to falsely portray the Latin Kings as a public service organization.

Cornell also held media events with community leaders to demand that the Greensboro Police Department disband its gang enforcement unit. Cornell lost bids for a Greensboro City Council seat in 2009 and in November.

The other Latin Kings members indicted are Randolph Leif Kilfoil, 26; Jason Paul Yates, 31; Marcelo Ysrael Perez, 26; Irvin Vasquez, 22; Wesley Anderson Williams, 19; and Carlos Coleman, 19.

The indictment does not say where the defendants live or where they are being held. A grand jury in the Greensboro's Middle District of North Carolina returned the indictment under seal Nov. 29.

Man charged with raping Raeford woman

The victim told Cabrera to stop, but he didn't. As the woman walked away, Cabrera grabbed her from behind, police said. The two struggled, and Cabrera kicked the woman in the knee and threw her to the ground before raping her.

The woman called 911 afterward. Police caught Cabrera as he was trying to leave the area, police said.

Cabrera is charged with second-degree rape, first-degree kidnapping and misdemeanor assault on a female.

Bail was set at \$50,000.

Attempted Murder Suspect Sentenced To 10 Years

A Selma man will spend up to 10 years in prison after being convicted Thursday for the attempted murder and robbery of a convenience store owner last year. Sheriff's deputies said Javier Francisco Bautista, 20, **and Felipe Alejandro Ortiz**, 18, attempted to rob Shoeheel Gas & Grocery at 3195 Shoeheel Road outside of Kenly on October 15, 2010.

Investigators said Bautista entered the store and pointed a gun at a 13 year-old behind the counter. The owner, Donnie Lee Creech, emerged from a back room armed with a weapon and exchanged gunfire with Bautista who was fatally wounded by Creech. Ortiz fled from the scene but was found a short time later.

Ortiz was convicted Thursday of attempted first-degree murder and attempted robbery with a dangerous weapon. Creech was never charged by authorities, who said he acted in self-defense.

Chatham County- **Jorge Aguilera**, 34, of 1305 Sunset Place, Siler City, was **charged Nov. 21 with failure to appear and two true bills of indictment for felony kidnapping and felony first-degree burglary**, sheriff's deputies reported.

Aguilera is accused of breaking into the home his estranged girlfriend, Florentina Gonzalez Coria, shared with her brother and father on Oct. 1, 2006, and kidnapping their son.

According to Chatham County reports, four men forced their way into the home at gunpoint around 1:30 a.m. and bound all the occupants of the home with duct tape before taking the 2-year-old child and \$100 in cash.

Aguilera was awaiting trial on charges of domestic violence when the kidnapping occurred, the reports stated.

Robbers plead guilty in federal court

CLAYTON -- The two cousins who held up and assaulted a Walgreen's store clerk last July and moved on to steal a woman's car pleaded guilty to those charges Thursday in federal court.

Rhaim Moises Santiago, 18, and **Ishmael Avive Santiago**, 20, both of Holding Street, Clayton, were indicted by a federal grand jury in September. **They pleaded guilty Thursday to charges of robbery and using and carrying a firearm in the commission of a violent crime. Rhaim Santiago also pleaded guilty to carjacking.**

The sentencing hearing has yet to be scheduled, but it is likely to occur in the first week of March, according to Robin Zier, public information officer for the U.S. Attorney Eastern District of North Carolina. Both men could be sentenced life in prison.

At 12:39 a.m., July 28, the Santiagos and an unidentified 15-year-old entered the Walgreen's on the corner of U.S. 70 and Robertson Street in Clayton and held up the cashier with a rifle. Rhaim Santiago assaulted the cashier by striking them in the head with the butt of the firearm. The three obtained cash from the register and fled the store on foot. The clerk's name was not released by the police department.

The next day, at 7:30 a.m., Rhaim Santiago robbed Jessica Daniel at gunpoint, demanding the keys to her GMC Jimmy, which was parked nearby.

After a police chase, Santiago wrecked the vehicle and ran away from the scene. After a joint investigation by the Johnston County Sheriff's Office, the N.C. Highway Patrol and K-9 units from both the Clayton Police Department and the sheriff's office, they found Rhaim Santiago at home.

Ishmael Santiago voluntarily surrendered to the Clayton Police later that night.

Rhaim Santiago did not have a previous criminal record. Ishmael Santiago had been charged with drinking underage last January.

While Cobado lives along the I-95 corridor, well known for its drug trafficking, Allen said the Clayton police don't often make drug arrests involving people from Smithfield and Benson.

"It doesn't happen a lot in Clayton, I guess I could say that," Allen said. "I don't think that's a particular trend that we've noticed."

Captain Chris Strickland with the Johnston County Sheriff's Office said that drug activity is no better or worse in the southern part of the county than the northern part.

"Of course you have drugs going up and down 95, it's not related to that," Strickland said. "Of course drugs are a problem everywhere. I wouldn't say any particular area more than others at this point," Strickland said.

Cobado is in the Johnston County Jail in lieu of a \$50,000 secure bond.

Ortiz, 27, of 1169 Deer Run Drive, Randleman, was charged with two counts of felony trafficking in marijuana, felony conspiracy to traffic in marijuana, felony possession with intent to sell or deliver marijuana, felony possession of marijuana and felony maintaining a vehicle to keep controlled substance.

He was jailed and bail was set at \$2 million.

Man on run after allegedly stabbing brother Christmas Day

GIBSONVILLE — Police are still looking for a man **wanted for the attempted murder of his brother** on Christmas day.

Jose Gonsalo Flores-Lopez, 27, also known as “**Chalo**” or “**Animal**,” remains on the run with a woman and a child. He is believed to be armed and dangerous and authorities think he is still in the area.

Meanwhile, his brother, Jose Lopez, 33, of 103 Cedar St., Gibsonville, was still in intensive care at Moses Cone Hospital in Greensboro Tuesday. The extent of his condition wasn’t immediately known.

Flores-Lopez, **a native of El Salvador**, was at his brother’s home on Cedar Street on Christmas night when the alleged assault took place between 8 p.m. and 9 p.m., said Gibsonville police Chief Michael Woznick.

“The best we can determine is there was an argument and there was some alcohol involved,” Woznick said.

Lopez was trying to stop Flores-Lopez from allegedly assaulting a woman that police say is either Flores-Lopez’s wife or girlfriend.

“The victim was ultimately assaulted,” Woznick said.

Flores-Lopez allegedly stabbed Lopez in the chest, hitting his lung and cutting an artery.

“He was in really bad shape,” Woznick said. “If critical is the worst word, he was in critical plus when the ambulance left the house.”

Lopez’s family was home at the time and called 911. Flores-Lopez left the scene with the woman and a child.

“He fled on foot,” Woznick said. “No vehicles were mentioned.”

The incident was not the first time Gibsonville police have encountered Flores-Lopez on Christmas Day. Woznick said that Flores-Lopez was charged on Christmas 2008 for assaulting someone with firearm.

The fugitive operations division of U.S. Immigration and Customs Enforcement in Greensboro is assisting Gibsonville police. **ICE also is providing interpreters.**

Flores-Lopez is a reported SUR13 gang member and has multiple tattoos, including three dots between his thumb and forefinger that is allegedly an indicator of gang affiliation. He also has “SUR13” tattooed on his left shoulder and the word “Alondra” on his chest.

Police think Flores-Lopez is armed and dangerous. He has allegedly possessed firearms in the past, including an assault rifle, and is allegedly known to carry knives.

Elizabethtown man charged with felony statutory rape

ELIZABETHTOWN — An Elizabethtown man has been arrested and **charged with two counts of felony statutory rape of a minor and two counts of abduction of a child.**

Rogelio Labra, 30, of 114 Robin Dr., reportedly picked up the minor from school on two occasions and transported her to his residence, where investigators with the Bladen County Sheriff’s Office say the sexual assaults took place in May.

According to Capt. Rodney Hester, Labra would drop the young girl off near her residence after committing the sexual assaults.

Hester said Labra was arrested on Christmas Eve and is now in the Bladen County Jail under a \$100,000 secured bond.

Charges in Durham, Lexington results in combined \$4 million bond

A Lexington man was placed in the Davidson County Detention Center under two \$2 million secured bonds after being arrested by the Lexington Police Department on Saturday.

Honorio Valdez-Elias, 34, of 506 S. Hargrave St., has been charged with two felony counts of assault with a deadly weapon with intent to kill, felony discharge firearm into an occupied dwelling, two counts of misdemeanor assault by pointing a gun, misdemeanor possession of stolen goods, misdemeanor damage to personal property.

Authorities allege Elias assaulted Juan Carlos Leon with a .45 caliber semi-automatic pistol with the intent to kill him. A warrant stated that Valdez-Elias assaulted Arzate Gomez with a .45 caliber semi-automatic with intent to kill her.

A warrant also states that Valdez-Elias fired six shots through the front door of an apartment on Nation Avenue in Durham while knowing the property was occupied by Leon and Gomez.

According to Lexington Police, the arrest was made at the home of Valdez-Elias after officers responded to a home Hopedale Street in regard to shots fired and a suspicious person. Valdez-Elias was identified as the subject who was outside the residence and fired the shots.

The arrest report stated that a woman who lived at the home said Valdez-Elias came to her residence looking for her boyfriend.

"She would not open the door and shook her head no, telling him her boyfriend was not there," a Lexington Police officer wrote in the arrest report. "She sat back down on the couch and heard gunshots outside the residence. She took her kids to the back of the house and hid until she thought he was gone and called police."

Valdez-Elias received a \$2 million secured bond for the incident in Durham and a \$2 million secured bond in Lexington. He has a court date of Jan. 24 for the Lexington charges and Feb. 15 court date for the Durham charges.
