## **Mother arrested after 2 toddlers die in fire**

Charlotte mom faced charges before 2 kids died in fire

The mother of two unsupervised toddlers killed in a west Charlotte house fire early Sunday was arrested and charged with murder and felony child abuse.

After a day of searching, Charlotte-Mecklenburg police arrested **Orgal Paulette Opata**, 26, after she left her four children alone at the home on Rowan Street, in the Thomasboro community. One-year-old Gabriel Hawthorne and his 2-year-old brother, Josiah Hawthorne, died in the fire that destroyed the home.

She was charged with two counts of murder, three counts of reckless/gross felony child abuse, exposing a child to fire and one count of burning resulting in serious injury to a firefighter.

Her two older children, a 4-year-old son and 7-year-old daughter, survived the fire after they were helped by a neighbor.

In 2007, Opata was convicted in Greensboro of possessing cocaine, and sentenced to at least six months in jail. Six years earlier, she was convicted of embezzlement, also in Greensboro, and sentenced to six to eight months.

Last October, Opata was charged in Charlotte with contributing to the delinquency of a juvenile and was awaiting trial before Sunday's arrest.

## **Pender patrol deputies nab man on drug charges**

Deputies say they saw drugs in plain view in the vehicle and searched to find more drug paraphernalia. Del Toro Segovia was pulled over after deputies clocked him going 95 in a 70 mph zone.

Del Toro Segovia is charged with Possession with intent to manufacture, sell and deliver Schedule 1 mushrooms. He is in jail on a \$20,000 bond.

## **2 Illegals charged in theft of spikes**

FLAT ROCK, N.C. -- Two men face deportation after they were arrested in the theft of more than 500 railroad spikes from train tracks still in use in western North Carolina.

Multiple media outlets reported Tuesday the men were charged in connection with the spikes from train tracks near Flat Rock.

Police say they found 37-year-old **Cruz Mario Carnacion** and 35-year-old **Jose Luis Trejo-Yanez** with more than 500 7-inch steel spikes, which can be sold for scrap.

Henderson County Sheriff Rick Davis says the missing spikes could have caused a derailment.

The men are charged with conspiracy to damage railroad property, willful injury to railroad property and trespassing on railroad property. They're being held on Immigration and Customs Enforcement orders pending deportation proceedings.

## **Driver in July hit-and-run fatality indicted**

NEWTON - A grand jury indicted the woman accused of killing a man with her car and then fleeing the scene of the wreck.

On Monday, **Tiffany Vasselto**, of Black Walnut Drive, was indicted on charges of felony hit-and-run, failure to maintain lane control and misdemeanor death by motor vehicle.

**Reynardo Funez**, 27, lived in Lenoir but worked in South Carolina. He and a coworker were to meet on the shoulder of U.S. 321 southbound and the N.C. 127 on-ramp on July 27. It was shortly after 4 a.m. when Funez's wife parked the car.

Funez stepped out of the car and reached for a bag of clothes inside when a Nissan Xterra driving south on the N.C. 127 ramp hit him. Funez was thrown between 50 and 100 feet from the car, and died at the scene of the accident, according to the N.C. Highway Patrol.

Although the driver of the Xterra turned off its headlights and fled the scene, officials found the SUV later that day, after an area attorney reported seeing the Xterra parked at a home.

Investigators knew on July 27 Tiffany Vassello was the owner of the car, but it took several more days of investigation to confirm she was the driver during the hit-and-run.

Vassello's next court date is May 3.

## **N.C. men face drug charges**

Two men are accused of bringing five ounces of cocaine from North Carolina to Berkeley County, where police said they sold it to an informant in the Food Lion parking lot in Inwood, W.Va., on Friday for \$4,500, according to Berkeley County Magistrate Court records.

**Miguel Hernandez**, 26, and **Eleazar Galvan-Soriano**, 31, both of Raleigh, N.C., each were charged with transporting a controlled substance into West Virginia and conspiracy to deliver a controlled substance, according to court records.

Galvan-Soriano also was charged with delivery of a controlled substance and Hernandez was charged with obstructing a police officer after he resisted arrest.

## **Man arrested for having sex with minor over 8-year period**

The Henderson County Sheriff's Office arrested a man for having sex with a girl for 8 years since she was only 10 years old.

**Luis Antonio Cruz**, 42, of Howard Gap Road in Hendersonville was charged with four counts of second-degree rape, two counts of attempted second-degree sex offense, indecent liberties with a child and one count of felony child abuse, all of which are felonies.

“Mr. Cruz was identified by our 287(g) unit as being in the country legally, but not a citizen,” Sheriff Rick Davis said. “Persons in this category, after completion of a sentence, are deported as an aggravated felon and returned to their country of origin.”

Cruz was processed at the Henderson County Detention Center where he was placed under a \$280,000 secured bond.

## **Police arrest 2 N.C. men, seize 200 pounds of pot**

Two North Carolina men have been arrested and more than 200 pounds of marijuana and two vehicles were seized in a drug bust, Spartanburg County Sheriff Chuck Wright said.

Deputies charged **Edgar Quintanilla-Arteaga**, 24, and **Raudel Cortex Haro**, 30, with trafficking more than 100 pounds of marijuana. Both men are from Charlotte, N.C., and were being held in the Spartanburg County Detention Center.

Jail records did not show whether the men had an attorney.

## **Drug bust yields one arrest and 20 pounds of marijuana**

CLINTON - Sampson County investigators seized 20 pounds of marijuana, four guns and more than \$10,000 from a Clinton home that was searched Friday.

**Miguel Tamayo Rodriguez**, 62, of the 5500 block of Reedsford Road, was charged with trafficking in marijuana, possessing marijuana with intent to sell and deliver, and maintaining a drug house, according to a news release from the Sampson County Sheriff's Office.

The marijuana found at the house was packed in plastic bags, each containing a pound of the drug, the release said.

The street value of the marijuana was about \$16,000, the release said.

Investigators also found three rifles and a handgun, the release said.

Rodriguez's bail was set at \$100,000.

## Harnett County Grand Jury Gets Tough On Sex Offenders

**Crystal Anne Rodriguez**, 29, of the 60 block of Westside Drive, Cameron, was indicted on two counts of statutory rape of a 15-year-old for incidents that allegedly occurred between June 1 and July 31, 2009.

This is the second time before a grand jury for Mrs. Rodriguez, who in 2007 was indicted for having sex with a 14-year-old boy and fondling his 13-year-old brother. In January 2008 to two counts of misdemeanor sexual battery charges in that case.

The latest allegations came to light in October after the 15-year-old's family learned Mrs. Rodriguez and her husband, **Jose Luis Rodriguez**, 27, allegedly had sexual relations with the boy while he was living at their home on Lone Star Court.

**David Angel Reyes**, 23, of the 50 block of West Everette Street, Spring Lake, was originally convicted of one count of indecent liberty with a minor in March 2003, DOC records indicate. His indictment shows he allegedly moved in September 2009 without notifying deputies.

Hernandez, 35, was shot in the head and chest, according to an autopsy.

## Woman pleads guilty in plot to kidnap girls

A woman who helped her estranged husband translate a ransom note into English pleaded guilty Tuesday to conspiracy to commit kidnapping. **Linda Gonzalez**, 21, of Edinburg Texas faces a maximum of five years in federal prison for her part in the scheme to kidnap two girls from a bus stop in Cornelius, according to a press release by the U.S. Department of Justice.

The kidnapping plot was **Ruben Garcia Rosario's** idea, according to court documents. The girls were the daughters of a couple for whom he worked as a painter. He drove by their school bus stop several times, according to police, snapping pictures of the girls with his cell phone camera. He promised Gonzalez \$10,000 if she'd help translate the note, the release says.

Garcia was arrested Sept. 29 and is in Mecklenburg jail, charged with attempted kidnapping and conspiring to kidnap the two girls. Federal immigration officials have also placed a hold on him because he is an illegal immigrant.

The indictment says Garcia and Gonzalez wrote the ransom note over the telephone, which threatened to kill the children if they didn't receive money. Parents called police in early September, saying a man was at the bus stop in Cornelius early one morning, Cornelius Police Maj. David King said at a news conference following the arrest. The parents provided a description of the car, but it was gone before police arrived.

On Sept. 22, police got another call from parents - the man taking pictures was back, and this time they had a license plate number.

Charlotte-Mecklenburg police arrested Garcia and charged him with driving without a license and carrying a concealed weapon. But after he was interrogated, officers say he told them about the kidnapping scheme. When officers searched his car, they found several ransom notes, pictures of the girls, a loaded gun, duct tape, latex gloves, a ski mask and two Mexican passports.

## **Suspect flees in wake of Monday Cashiers shooting-2 captured**

Two are in custody and one suspect remains on the run in the wake of a Monday (March 22) shooting that injured a Tuckasegee man.

The incident occurred in Cashiers near the former Summit Charter School, and the dispatch center received the 911 call at 11:20 a.m. The call came in from a male subject who advised that his co-worker had been shot in the leg.

Wanted in connection with the shooting is **Jonathan Garcia Lugo**, 27, who was last seen fleeing the scene in a black Chevrolet S-10 pickup truck heading West on U.S. 64 toward Macon County. At least one other person left with Lugo, according to Jackson County Sheriff's Office staff attorney Mark Welch.

The victim, **Fernando Randel Lopez**, 42, suffered a single gunshot wound to the left leg and was transported to Mission Hospitals in Asheville. He was working at a construction site near the old charter school, which is close to the Cashiers Post Office when the black Chevrolet pickup pulled up. According to Capt. Steve Lillard, witnesses say four occupants exited the vehicle. Based on information obtained during the investigation, Lugo then shot Lopez.

While no motive has been established, Welch says the incident may have been a dispute over a girlfriend and that Lopez was apparently shot while he was trying to prevent a fight.

In custody in connection with the incident are **Ricardo Pineda Sanchez**, 26, listing a Yellow Mountain Road address in Glenville; and **Oswaldo Lira Parga**, 19, listing an address in Wichita, Kan. Both Sanchez and Parga face charges of felony conspiracy to commit an assault with a deadly weapon inflicting serious injury with Intent to kill, and both are jailed under a \$30,000 bond.

Lugo faces that charge plus one count of felony conspiracy.

The suspects left the area in a full-sized, dark-colored SUV. The victims were able to give a description of the vehicle to a 911 operator. A responding patrol deputy spotted a vehicle that matched the description a few miles away and stopped the vehicle, according to the sheriff's office.

Four suspects were taken into custody. After further investigation, they were charged with three counts each of attempted murder.

Deputies identified the suspects as **Christian Dominguez**, 19, of Lomond Street, Winston-Salem; **Mario Dejesus Navarro Cruz**, 17, of Hutton Street, Winston-Salem; **Luis Miquel Martinez**, of Divenshire Street, Winston-Salem and **Raul Benitez Jr.**, 17, of Barnes Road, Winston-Salem.

The suspects were jailed after going before a magistrate, who set their bonds at \$1 million each.
