## Shooting Victim In Stable Condition

A Smithfield man is in stable condition at Wake Med after being shot Sunday night. The incident happened at a home on Black Creek Road off Highway 210. Mark Thornton, 35, told sheriff's deputies he answered a knock on his door around 10pm **and saw a Hispanic male standing outside**. The suspects reportedly said a few words in Spanish then shot Thornton in the shoulder. Thornton was unable to give authorities a description of the assailant. Investigators said two of Thornton's relatives were inside the home at the time of the shooting but allegedly did not hear or see anything. Smithfield EMS paramedics rushed the victim to a WakeMed air ambulance at the Johnston County Airport where he was airlifted to the hospital. Johnston County sheriff's detectives are still investigating the incident.

## Drugs, cash seized in biggest drug bust in WNC history

ASHEVILLE— Deputies with the Buncombe and Henderson County Joint Highway Interdiction Team seized 1,082 pounds of marijuana and over \$1.1 million dollars in cash during a routine traffic stop Thursday in Buncombe County along I-26.

It is the largest drug bust in WNC history, said Buncombe County Sheriff Van Duncan and Henderson County Sheriff Rick Davis at a press conference this morning.

Deputies arrested Andrew Vanover of Kentucky and **Jose Florez** of Texas and charged them with trafficking marijuana and other charges.

The two men are being held in the Buncombe County jail under \$100,000 secured bond.

Deputies have charged **Carolino Perez** with felony flee to elude arrest, DWI, injury to real property and no operators license.

A news release says around 9:10 p.m. Saturday night, deputies went to a domestic assault call on Hickory Drive. A deputy tried to talk with a man sitting in a SUV that was parked in front of the victim's home, but the vehicle sped off.

Deputies say they began chasing the SUV down River Road, with the vehicle driving around 80 miles per hour. As the SUV approached Asbury Church Road, the vehicle lost control, jumped a curb, struck a parked vehicle and then crashed into the La Guadelupana Tienda Mexicana store.

Deputies say two people inside the parked vehicle escaped injury, while the store employee received minor injuries from a door as she left the building.

The 24-year-old Perez was treated at the hospital before being arrested. He's in the Beaufort County jail on a \$25,300 bond.

## **Three Illegals apprehended**

**BEAUFORT** — Authorities from two Carteret County agencies assisted Immigration and Customs Enforcement officials in the apprehension of three federal fugitives during the early hours of Thursday, Jan. 28.

**Ehab Mohammed Ahmed Chareeb**, **Bassem Fangary** and **Francisco Mondragon Limon**, all of Middle Eastern decent, were said to be in the United States illegally. Mr. Chareeb is part owner of Everyday Italian Restaurant on Chatham Street in Newport. Authorities said Mr. Chareeb and Mr. Fangary were picked up at an undisclosed location in the county.

Sheriff Asa Buck said Mr. Limon, was arrested on Tuesday, Jan. 26, after he made calls to the 911 Communications Center here and would not give his reason for calling or provide an address.

“He called the center several times, but would not say why and would not give us a location. We still do not know why he called,” said the sheriff. “But, he certainly made it easier for us to locate him.”

Deputies located Mr. Limon on Mayberry Loop Road and he was taken into custody.

Deputy Tim Quillen had contacted ICE earlier concerning Mr. Limon and was informed he was on their list along with Mr. Ghareeb and Mr. Fangary.

“Our deputies, the Newport Police Department and the ICE agents worked together as a team in locating and removing these individuals from Carteret County,” Sheriff Buck said.

## Two charged in sexual assault on child

Two people were charged Monday in connection to a sexual assault on a child.

Burlington police received a report on Saturday that a 6-year-old girl was allegedly sexually assaulted. After an investigation, police charged **Jose Alfredo Valdivias**, 36, of White Pine Trail, Hillsborough with indecent liberties with a child. He was placed in the Alamance County jail under \$25,000 bond, according to a Burlington Police Department news release.

Robin Faye Brown, 30, of Styles Thompson Drive, Burlington, was charged with contributing to the delinquency of a minor. She was placed in jail under \$2,500 bond.

## Alleged drug ring busted

Granite Falls-A month-long investigation came to a close Friday when local authorities apprehended three men in connection with a local drug ring.

Members of the Caldwell County Sheriff’s Office ICE Unit, the North Carolina State Bureau of Investigation and the Granite Falls Police Department took **Jose Alberto Flores**, Benny Dale Laney Jr. and **Jose Manuel Flores** into custody after completing a search warrant at the home of Jose Alberto Flores. Each man faces a variety of drug charges and is confined to the Caldwell County Detention Center.

Jose Alberto Flores, 26, of 4471 Sawmills School Road, Granite Falls, was charged with felony possession with intent to sell and deliver marijuana and felony maintaining a dwelling to keep/store a controlled substance. Jose Alberto Flores, who became the focus of the investigation, also was served with a warrant for felony probation violation for second-degree burglary and possession with intent to sell/deliver a schedule six substance from authorities in Columbia, S.C.

Laney, 19, of 2615 Piper Lane, Lenoir, was charged with felony possession with intent to sell/deliver marijuana and felony maintaining a vehicle to keep/store a controlled substance. Reports show that officers caught Laney leaving the residence of Jose Alberto Flores with one pound of marijuana. He is being held under a \$9,000 secured bond and appeared in court Monday.

The third individual, Jose Manuel Flores, 34, of Conover, was charged with simple possession of marijuana and possession of drug paraphernalia. He was taken into custody when officers found him inside the home of Jose Alberto Flores and he was placed under a \$1,500 secured bond. Jose Manuel Flores is expected to make his first appearance on Thursday, Feb. 18.

GREENSBORO — Police said they have found the four men responsible for one of the largest heists in the city's history.

Greensboro police said four men face charges in the September break-in at the Diamond Gallery at 2811 Battleground Ave. that netted about \$1.2 million in jewelry.

Police identified the suspects as:

- \* **Abelardo Pena-Cardentey**, 32, of Ft. Lauderdale, Fla. He is due back in Greensboro today.
- \* **Jose Adonis Betancourt-Forras**, 43, of Miami, Fla. He remains in jail in Knoxville, Tenn., on an unrelated charge, and police are trying to extradite him to Greensboro.
- \* **Maykel Roque**, 26, of Opa-locka, Fla. He is being held in jail in Key West, Fla., and is awaiting extradition to Greensboro.
- \* **Yenier Cardentey**, 29, of Hialeah, Fla. He is due back in Greensboro today.

The four men face charges of breaking and entering, larceny after breaking and entering, possession of stolen goods/property, conspiracy to commit a felony, possession of burglary tools and safecracking. Greensboro police said the jewelry store was burglarized sometime after 6 p.m. Sept. 19, when it closed for the weekend. The suspects entered the store through the roof and broke into three safes inside.

NEW HANOVER COUNTY, NC (WECT) - New Hanover County Sheriff's Deputies have arrested two illegal immigrants accused of trafficking cocaine.

The sheriff's office conducted a six-week investigation which ended Thursday during a traffic stop at Rogersville and Eastwood Roads. Detectives seized 10 ounces of cocaine, which has a street value of over \$28,000.

**Cirino Flores Mendoza**, 36 of Riegelwood, was charged with two counts of trafficking cocaine, possession with intent to manufacture, sell and deliver cocaine, possession of drug paraphernalia and no operator's license.

**Domingo Teran Flores**, 34 also of Riegelwood, was charged with two counts of trafficking cocaine, possession with intent to manufacture, sell and deliver cocaine and possession of drug paraphernalia. According to the sheriff's office, both men were found to be in the United States illegally.

## **Man stabbed after intervening in argument**

A New Bern man was airlifted to Pitt County Memorial Hospital in Greenville on Saturday after he was stabbed while leaving his apartment on George Street.

**Pedro C. Garcia**, 46, was reported to be in stable condition after receiving stab wounds to the neck area just before 3 p.m. Saturday, according to a news release from the New Bern Police Department. He had intervened in an argument between two Hispanic males inside the apartment before the stabbing occurred, according to witnesses.

The release states that he was stabbed by one of the men involved in the argument as he was walking down the steps to leave the residence of the building at the intersection of George and Julia Clay streets. New Bern police have identified a suspect in the stabbing but have not released the man's information.

## **\$7,000 Worth Of Cocaine Seized In Benson Drug Bust**

Two Harnett County men were jailed under \$1 million bonds each Wednesday night following their arrests on cocaine trafficking charges. Narcotic agents with the Johnston County Sheriff's Office allegedly seized 70 grams of powder cocaine, with an estimated street value of \$7,000, following an undercover drug buy in the parking lot of the Food Lion in Benson. **Noe Lopez Hernandez**, 28, of Bayleaf Road, Coats, and **Aaron Alvarez**, 23, of Spencer Road, Lillington were arrested. Both men are charged with 5 counts each of trafficking cocaine and one count each of conspiracy to traffic cocaine. Hernandez was charged with an additional count of maintaining a vehicle to keep a controlled substance.

Narcotics Captain A.C. Fish said the arrests followed a two-month drug investigation involving the suspects.

## **5 ROBBERS PLEAD GUILTY**

RALEIGH - United States Attorney George E.B. Holding announced that in federal court on January 25, 2010, **Humberto Diaz**, **Ever Jose Contreras**, **Jose Leonel Matute**, **Axel Contreras** and **Daniel Edgardo Rodriguez**, all illegal aliens from Honduras residing in Wallace, North Carolina, pled guilty to conspiring to commit Hobbs Act robbery, in violation of Title 18, United States Code, Section 1951, and aiding and abetting the use of a firearm in furtherance of a crime of violence, in violation of Title 18, United States Code, Section 924(c).

This case was part of the Project Safe Neighborhoods(PSN) which encourages federal, state, and local agencies to cooperate in a unified “team effort” against gun crime, targeting repeat offenders who continually plague their communities.

Investigation of this case was conducted by the Federal Bureau of Investigation - Wilmington Office, the Pender County Sheriff’s Office and the Wallace Police Department.

All face up to life imprisonment on the charges.

CHARLOTTE, N.C.-- Police have arrested three people in connection with a body found in a Dumpster Friday.

Police were called to the Windgate Apartments around 4:30 p.m.

A maintenance worker at the complex was responding to a call for a broken pipe in an apartment and found blood. The worker called 911 and police later found the victim in a trash container at the apartment complex.

Police say the victim had been subletting the apartment. Investigators still have not released the victim's name.

Three people have been arrested in connection to the murder, but they have not been charged with murder. **Juan Alberto Rivera-Amaya**, **Yadira Fernandez** and **Isidro Bueno** are all charged with concealment of death. Bueno is also charged with maintaining a place for prostitution.

## Suspect Indicted For Molesting Three Children

Authorities arrested and charged a Mooresville couple this morning after finding marijuana in their 3-year-old's diaper bag in their car.

Rowan County investigators charged **Pedro Alberto Jaramillo-Garcia**, 24, and **Tiffany Ann Jaramillo-Garcia**, 19, with one count each of felony possession with intent to sell and deliver marijuana, felony maintaining a vehicle to keep, store and sell a controlled substance and misdemeanor contributing to the delinquency of a minor. Both are in the Rowan County Jail this morning on \$5,000 secured bonds.

The county Department of Social Services has custody of the child.

Investigators said they had received information from a concerned resident that a drug delivery was being made in the Bear Poplar Road area of western Rowan County. They responded to the area and found bags of marijuana in the diaper bag in the couple's car.

Investigators also said **Pedro Jaramillo-Garcia is in the country illegally.**

## **Task force takes down cocaine cartel in Newton Grove in Operation: Northern Star**

U.S. Attorney George E.B. Holding announced Thursday the conclusion of an investigation in Wayne and Sampson counties that resulted in the convictions of **26 people** believed to have been members of a **Mexican drug cartel** operating in eastern North Carolina.

The Organized Crime Drug Enforcement Task Force's Operation Northern Star targeted **the Julian Avilez drug trafficking organization**, which Holding said operated out of a Newton Grove convenience store. Avilez used the store as his base of operations to import up to 30 kilograms of cocaine per month from Mexico, to distribute it throughout the southeastern United States and to launder money from the sales, Holding said.

The 26 defendants were charged with crimes including conspiracy to distribute cocaine, cocaine base (crack), marijuana, and methamphetamine; distribution of cocaine, cocaine base (crack), marijuana, and methamphetamine; domestic and international money laundering; and illegal possession of firearms. The ringleader, Avilez, was sentenced to more than 15 years in prison. All but two of those convicted have been sentenced, Holding said, to terms ranging from 60 to 292 months.

The task force seized 14 firearms, 11 kilograms of cocaine, 2 kilograms of crack cocaine and more than \$1 million in cash during the course of the three-year investigation, he said.

**CLINTON, N.C.** — One person was killed when the roof of a church in Sampson County collapsed on Thursday afternoon, authorities said.

The Sampson County Highway Patrol said crews were working on the roof of the new sanctuary at Mt. Vernon Baptist Church, 3790 Faison Highway in Clinton, when it collapsed just before 4:30 p.m. Two others were injured and taken to Sampson Regional Hospital. One of the patients was later airlifted UNC Hospital.

When the collapse happened, crews were replacing wood around the structure that had just been put up hours before, construction worker **Orlando Martinez** said. The crane operator had just wrapped up his work and the crew was trying to stabilize the building.

“We’re taking some two by fours out and every time we took it out, we heard a sound,” Martinez said. “And then suddenly half the structure came down.”

Martinez and the two men with him were working on the part of the structure that did not cave in. In all, nine men were working on the structure when it gave way.

The man who was killed had only been on the job for two days, Martinez said.

"He was glad," Martinez said. "He was happy that he found a job. He was a happy man."

Seven men were charged Wednesday with conspiracy to distribute marijuana after agents seized marijuana following surveillance of suspicious activity in Charlotte on Jan. 20, the Charlotte Observer reported.

The men arrested and charged are **Donaciano Aguirre-Ramos, Oscar Garza, Roberto Alonzo Robledo, Genaro Yoc-Hernandez, Saul Gonzales-Andrade, Carlos Buendia-Gallegos and Martin Palomo.**

The agents followed a van leading a truck with Texas license plates to an automotive shop, where, allegedly, the men worked all night preparing the marijuana, the Observer reported.

When a van left the shop's garage early the next morning with its headlights off, surveillance units pulled the van over, the newspaper said.

Two thousand pounds of marijuana in plain view were in the van, officials said, and when a second van started to leave the shop, agents stopped it, too.

The pot was bundled into a total of 252 bales, the Observer said.

## Two more arrested in Eden drug bust

Two more arrests have been made in connection with a drug bust which took place Friday, Feb. 19, in the city of Eden.

According to a news release from the Rockingham County Sheriff's Office, Patricia Galloway, 53, of Carolina Avenue in Eden was charged with trafficking in marijuana. Her bond was set at \$200,000.

**Roberto Carlos Becerra**, 29, of Eden, faces six felony counts of trafficking cocaine, one felony count of

selling/delivering marijuana and one felony count of possession with intent to sell/deliver marijuana. He was jailed on \$500,000 bond.

Narcotics detectives with the sheriff's office, Eden Police, Caswell County Sheriff's Office, Henry County (Va.) Sheriff's Office, Mayodan Police and the North Carolina State Bureau of Investigation joined together in a task force to combat the drug activities of this drug trafficking organization. A year-long investigation ended with the service of both search and arrest warrants.

Working together, these agencies served warrants at three different residences in Eden. As a result of those searches, law enforcement agencies seized more than 800 pounds of marijuana with an estimated value of \$640,000; several ounces of cocaine; firearms and 16 vehicles.

**Seven of the nine suspects who were arrested were found to be in the United States illegally.** They will be detained for U.S. Immigrations and Customs Enforcement.

## **SC deputies arrest 2 NC men, seize 200 pounds of pot**

SPARTANBURG, S.C. (AP) — South Carolina police have arrested two North Carolina men and seized more than 200 pounds of marijuana and two vehicles in a drug bust.

Spartanburg County Sheriff Chuck Wright said at a news conference Friday that the arrest came the night before after investigators received a tip.

Deputies charged 24-year-old **Edgar Quintanilla-Arteaga** and 30-year-old **Raudel Cortex Haro** with trafficking more than 100 pounds of marijuana. Both men are from Charlotte, N.C.

Investigators say Haro was driving a luxury sedan and was trying to act as interference for a pickup truck with an enclosed trailer. When the cars were pulled over in a traffic stop after the sedan nearly hit a deputy's cruiser, a police dog alerted officers to drugs in the trailer.

## **Drug Dealer Sentenced to 15 Years in Prison**

A North Carolina drug dealer was sentenced to 188 months in prison Thursday for being convicted on drug conspiracy and witness intimidation, according to a news release from the U.S. Attorney's Office. An investigation from the Central West Virginia Drug and Violence Task Force in Summersville, led to the arrest of **Hugo Santamaria**, 30, of Monroe, N.C.

On March 15, 2006, a search warrant at a home in Birch River, W.Va. helped task forces discover one kilogram of cocaine, paraphernalia, several firearms, cash and packaging, according to the news release. Those at the resident in Birch River identified Santamaria as their drug supplier.

Trial witnesses stated that Santamaria supplied cocaine and marijuana from 2001 to June, 2006 in Nicholas, Preston, and Monongalia Counties in West Virginia, according to the release.

Santamaria was also found guilty of two counts of witness intimidation, according to the news release.

Santamaria made threats against those, and their families, who he believed would cooperate with authorities or testify against him in trial, according to the news release.
