HICKORY, N.C. —A Hickory woman whose husband is facing [a felony sex charge involving a child](#) has been arrested for running an unlicensed day care where police say the incident occurred.

Authorities say 41-year-old **Crisofor Parra Casareal** and his wife, 32-year-old Tonya Lynn Casareal, live at the house where police say the day care operated. Hickory police received a report of a child being sexually assaulted at the home on July 9.

Cristofor Casareal was arrested on July 11 and [charged with indecent liberties with a child and first-degree sexual assault.](#) His status couldn't be determined Thursday.

An arrest report says Tonya Lynn Casareal is charged with one count of felony operating an unlicensed day care. She is jailed on a \$3,000 secured bond. It's not known if either have an attorney.

YADKIN COUNTY, N.C. – A man has been arrested in connection with sexual offenses with a child, according to the Yadkin County Sheriff's Office.

**Augustin Perez Jr.**, 22, of Blackville, S.C., was arrested on Thursday and charged with felony first-degree sexual offense, felony indecent liberties with a child and felony second-degree sexual offense.

In November 2012, the Sheriff's Office received a report from a family that a close family friend, who was living in Yadkin County at the time, had victimized their child.

Following an investigation, warrants were taken out for Perez. His location at the time was unknown. He was subsequently located in South Carolina and brought back to Yadkin County.

Perez is being held under a \$300,000 secured bond. He is scheduled to appear in court June 25.

### **Leland sexual assault suspect arrested**

LELAND, NC (WECT) -

A man accused of indecent liberties with a child is back in the Brunswick County Jail after being arrested in Idaho July 3.

According to the Leland Police Department, officials received a report May 13 that **Fernando Vargas-Julio** was the suspect in a sexual assault.

Over the course of the investigation detectives learned that some of Vargas-Julio's assaults also occurred outside of the Leland town limits, so the Brunswick County Sheriff's Office was contacted.

Through a joint effort between the Leland Police Department and the Brunswick County Sheriff's Office, warrants were obtained by both agencies for Vargas-Julio for two counts of first degree sex offense with a child, three counts of Indecent Liberties with a child, two counts of crimes against nature, and disseminating obscenity to a minor.

Vargas-Julio is also charged with three counts of indecent liberties with a child, and two counts of failure to appear on a misdemeanor.

Detectives learned information regarding the location of Vargas-Julio and passed it on to the Wilmington Division of the United States Marshal Service Eastern North Carolina Violent Fugitive Task Force for apprehension.

The Wilmington Division of the U.S. Marshals E/NC Violent Fugitive Task Force accepted responsibility for Vargas-Julio from the Leland Police Department in late May.

From there, the Marshals Task Force conducted several interviews regarding Vargas-Julio until they developed information late on July 2 that Vargas-Julio was staying with a friend in Jerome, ID. That information was forwarded to U.S. Marshals Service Task Force in Idaho early July 3.

Due to the time sensitivity of the information, the members of the task force immediately made the two hour trip to Jerome and found Vargas-Julio at Millenkamp Cattle Ranch working as a laborer under a fictitious name.

Vargas-Julio initially gave false identification to Deputy Marshals; however, they were able to positively identify him from pictures. Marshals arrested Vargas-Julio around 2 p.m. July 3.

Vargas-Julio is currently in the Brunswick County jail under a \$500,600 secured bond.

### **Forsyth Co. man hired by family to mow lawn raped 12-year-old girl**

FORSYTH COUNTY, N.C. — A girl testified in Forsyth Superior Court this morning that the man hired by her family to mow the lawn pushed his way into the house and raped her in a darkened bathroom, according to the Winston-Salem Journal.

**Francisco Marquez Martinez** of Cole Road is on trial this week on three charges – rape of a child, sex offense with a child and taking indecent liberties with a child.

Assistant District Attorney Kia Chavious said in an opening statement that the alleged incident happened on June 22, 2012.

The girl was twelve at the time and was alone with her younger sister when Martinez came to the door, Chavious said.

The Winston-Salem Journal does not typically identify the alleged victims of sexual assault or their families.

The girl testified that Martinez knocked on the door and told her that he was there to cut the grass. He was supposed to have come the next day, a Saturday, and the girl called her mother, who was not home.

After talking to her mother, she handed the phone to Martinez, the girl said. Martinez told the mother that he had a scheduling conflict and couldn't come that Saturday.

The girl said that Martinez went to cut the grass and she locked the door. A little while later, it began to rain, and Martinez knocked on the back door. He asked her if he could come in.

The girl said she told Martinez he could stand in a covered area just outside the kitchen but he couldn't come into the kitchen.

That's when Martinez told the girl she had a string loose on her clothing, the girl said. Martinez then grabbed her and began touching and kissing her. She ran away and Martinez ran after her into her mother's room.

The girl said Martinez pinned her on the bed and began kissing her on her neck and breasts. She pushed him onto a dresser and ran into the bathroom.

Martinez followed her in, pushed her into the bathtub and closed the door.

She couldn't see anything because it was dark but she heard Martinez unbuckle his pants. She said she felt pain when he assaulted her.

She said she hit him and he stopped. He opened the door and she ran down the hallway to her room to make sure her sister, who was sleeping, was okay.

Martinez, she said, ran out the back door.

ASHEVILLE – A man being sought on charges of sexually assaulting a handicapped woman was arrested early Tuesday.

**Freddy Norberton Henriquez**, 46, of 63 Vandalia Ave., was [charged with sexual battery and assault on a handicapped person](#), according to warrants at the Buncombe County magistrate’s office.

The victim was described in the warrants as “mentally disabled.” Henriquez is accused of “using his body weight to hold her down while making sexual contact with her,” according to warrants.

Henriquez also was served with an outstanding warrant from 2003 for simple assault in which he’s accused of assaulting a man.

Buncombe sheriff’s officers announced Monday they had taken out warrants against Henriquez for the alleged assault on the woman and were looking for him.

Henriquez is being held at the Buncombe County Detention Facility under a \$6,000 secured bond.

NEW HANOVER COUNTY, NC (WECT) - A man is behind bars after being charged with indecent liberties with a teen.

Officials at Immigrations and Customs Enforcement placed an ICE detainer on **Carlos Perez-Dominguez** following his arrest. According to ICE, he was previously deported in December of 2013:

*"ICE placed a detainer on Carlos Perez-Dominguez, a citizen of Mexico, with the Hanover County Jail following his arrest on local criminal charges. ICE previously removed Mr. Dominguez from the U.S. in December 2013. By issuing a detainer, ICE requests that a law enforcement agency notify ICE before releasing an individual to allow ICE to assume custody. Any immigration enforcement action ICE takes in this case will follow the complete adjudication of his criminal charges."*



Dominguez, 30, is in the New Hanover County Jail under a \$1.4 million secured bond on indecent liberties with a child charges.

He is also charged with child abuse, two counts of failure to appear on misdemeanor charges, and resist/delay/obstruct public officers.

According to the Wilmington Police Department, the victim in this case has been identified as a 14-year-old boy.

Dominguez's next court date is Aug. 14. According to ICE, any action they take in the case will occur after a potential criminal conviction in New Hanover County.
