## Garner man arrested on child sex charges

GARNER, N.C. (WTVD) -- Garner police said 22-year-old **Ezequiel Estrada is facing multiple charges of raping a child under the age of 13.**

According to the arrest warrant, the victim was just 12 years old.

Estrada is being held in the Wake County Jail on a \$5 million bond. In addition to \$5 million bond, **the Immigration and Customs Enforcement Agency put an immigration hold on Estrada**

## Illegal immigrant pleads guilty to raping 6-year-old girl

BRUNSWICK COUNTY, NC (WWAY) -- An illegal immigrant has pleaded guilty to raping a six-year-old Shallotte girl in 2010. **Luis Arturo Sanchez, 23, entered a guilty plea this afternoon in Brunswick County Superior Court to first degree rape.**

Prosecutors say at the time of the crime, **Sanchez was in the United States illegally.** Assistant District Attorney Meredith Everhart said in court during the plea that Sanchez had confessed to engaging in intercourse with the child on one occasion and to attempting sexual intercourse with her on at least two other occasions.

Judge Ola Lewis sentenced Sanchez to 12 to 15 years in prison. Sanchez will also be required to complete sex offender treatment in prison, register as a sex offender and be subject to GPS satellite monitoring for the rest of his natural life.

As a result of his status as an illegal alien, the United States Office of Immigration and Customs Enforcement (ICE) has placed an immigration detainer on Sanchez, which requires his deportation from the United States, but that will only occur after he has served his entire active prison sentence in the United States.

## Family Friend Charged With Sexual Assault

## Monroe man arrested on indecent exposure charge

MONROE, N.C. — A Monroe mother said she is outraged after her neighbor fondled himself in front of her young daughters.

Sue Sprouse said it happened as her children and other kids played in their back yard Thursday night. She said it's the second time she's had to call police this week.

"My kids came in running up there and telling me there was a naked guy outside," she said.

Sprouse said she walked up a hill and saw **Agusto Gonzalez** passed out and exposed. Her two daughters said he'd been fondling himself in front of them.

"I was very angry," Sprouse said.

Sprouse said she recognized him as the same man that her kids found in the back yard Tuesday.

"They were like, 'Mommy there's a guy dead', so I thought to help him and then I saw his pants down and said I'm not helping," said Sprouse.

She said she called the police after each incident.

"I think he had a little too much to drink, because he was passed out," said Lt. T.J. Goforth of the Monroe Police Department.

Police arrested Gonzalez Thursday, **charging him with indecent exposure.**

## Man accused of raping two children

STATESVILLE – The sheriff's office is investigating after two children were sexually assaulted.

According to officials, a report was filed on May 8 that listed two minors as the victims. Reportedly they were sexually assaulted by 33-year-old **Jose Angle Guzman.**

One of the victims told authorities the assaults were happening since 2009. Investigators said the second victim has an interview scheduled in the coming weeks.

**Guzman is facing a slew of charges including first degree rape and first degree sex offense.** He was taken to the Iredell County Detention Center and placed under a \$50,000 secured bond.

**In a press release sent to media, authorities said they had some questions concerning Guzman's immigration status.**

The investigation is ongoing. Investigators say more charges will be filed against Guzman. Officials said they have questions about Guzman's immigration status.

## **Judge Sentences Couple To Prison For Abusing Baby**

A Johnston County couple has been sentenced to prison for abusing their 6 week-old daughter. The incident happened in August and Selma Police arrested the couple in December. **Norberto Velasco Lopez**, 26, and **Claudia Hernandez Nava**, 19, both of West Noble Street, Selma were **charged with child abuse. The baby sustained 5 broken bones, including a broken arm and leg.**

Last week, Lopez was convicted of negligent child abuse and was sentenced to serve 19 to 32 months in prison. He was given credit for 160 days in custody while awaiting trial. Nava was convicted of misdemeanor child abuse and was sentenced to 45 days in jail.

Social workers took custody of the child following the incident.

## **Iredell man faces child sex crimes**

A Statesville man is facing dozens of sex crimes after he was accused of **assaulting two children** over a span of several years.

The Iredell County Sheriff's Office said it received a report on May 8 that two children had been sexually assaulted. The first victim revealed to investigators that the assaults had been going on since 2009.

On May 12, authorities arrested **Jose Angle Guzman**, 33, charging him with first-degree rape, first-degree sex offense and indecent liberties with a child.

Then, in an interview with the other victim last week, authorities learned that Guzman began sexually assaulting the second child several years ago, according to the Sheriff's Office.

As a result of the second investigation, authorities **charged Guzman with 12 counts of first-degree rape, 12 counts of first-degree sex offense and 24 counts of indecent liberties with a child.**

Authorities did not say how Guzman knew the victims.

He was being held in Iredell County jail.

## **Arrest Made In Kidnapping, Rape Investigation**

## **Two jailed in kidnapping**

Two people remained in custody Monday, accused of holding a woman captive and threatening to kill her if she tried to escape, an official said Tuesday.

**Reyna Lopez Blanco**, 39, and **Leobardo Gonzalez Zapata**, 30, are each being held in the New Hanover County jail on **one count of kidnapping.**

The two were arrested about 3 p.m. Saturday at their Simon Street home.

According to Wilmington Police Department Cpl. Kevin Smith, a woman in her 20s called 911 Friday and reported Zapata and Blanco had lured her from Greensboro to Wilmington with the promise of a job.

Once here, they allegedly took her cell phone, kept her against her will for "less than a week" and threatened to kill her, Smith said.

Smith said that somehow the victim was able to get a phone and call for help.

Zapata and Blanco are each being held on \$250,000 secured bond.

Smith said **Immigration and Customs Enforcement is taking over the investigation.**

## Suspect arrested in Supply shooting

A suspect was arrested Monday in a weekend shooting that wounded two people in Supply, according to the Brunswick County Sheriff's Office.

**Jonathan Cores Molina**, 28, was **charged early Monday with discharging a firearm into an occupied building**, according to Sgt. Del Routh.

Routh said officers were called to 2528 Blue Marlin St. just before 1 a.m. Sunday. By the time deputies arrived, two people had already been taken by private vehicle to Brunswick Novant Medical Center with gunshot wounds, he said.

Jose Aguire, 29, and Francheska Rivera Rodriguez, 23, suffered non-life-threatening injuries, Routh said. Aguire was later released from the hospital.

Routh said it appears they were inside the mobile home when shots were fired from outside.

A second man initially was being sought in the shooting, but he is no longer a "person of interest," Routh said.

## 3 facing cocaine trafficking charges after drug ring bust

NEW HANOVER COUNTY, NC (WECT) – Three men are facing drug charges following an extensive investigation conducted by the New Hanover County Vice and Narcotics Unit, according to a statement from sheriff's officials.

**Abel Robles-Amaral**, 24, **Zenon Solis-Islas**, 27, and **Justino Solis Santos**, 32, were all **arrested on multiple cocaine trafficking charges** on Monday evening.

Federal agencies are stepping in to assist with the investigation, which is ongoing, and began in January.

According to Captain Ciamillo, the suspects sold significant amounts of cocaine in Wilmington.

## Teens Charged With Trafficking Cocaine

Two Selma teens are facing serious cocaine trafficking charges following an undercover operation involving Selma Police narcotic agents. Around 1:30am May 9, police allege the two suspect delivered one ounce of powder cocaine to a location on West Waddell Street before their car was surrounded and they were arrested.

**Oscar Rene Seriano**, 19, of Center Street, and **Lucas E. Mazzo-Gonzalez**, 19, of Shadow Bend Court, were **charged with trafficking cocaine** and each was confined in the Johnston County Jail in lieu of a \$100,000 bond.

Detective S.C. Richardson said the drugs had a potential street value of \$1,200. Richardson said the teens did not realize they were talking with an undercover officer when they were setting up the drug deal, reportedly as a way for the two fast food workers to make extra money. The new Selma Police Department K-9 “Gin” was also used in the takedown.

## **Whopping cocaine bust stuns Johnston Co. officials**

PRINCETON, N.C. -- A weekend DWI checkpoint in Johnston County netted **22 pounds of cocaine** worth an estimated \$1 million on the street.

Princeton Police Chief Tyrone Sutton said the bust was the largest that Princeton police have ever acquired.

“We do not normally see this large quantity of a controlled substance in this area. It was quite a find. We were able to get these drugs off the streets, which was our main purpose,” said Sutton.

Authorities say **Daniel Rabiela Gonzalez** and **Everado Rabiela Gonzalez** were believed to be driving from Georgia to the coast.

They were headed eastbound on U.S. 70 when they were stopped during the checkpoint for driving without a valid license. A Johnston County deputy discovered 10 one-kilogram bricks of cocaine hidden inside two back door panels of the car.

**Both men were arrested and are being held in the Johnston County Jail, each on \$5 million bond. They face three counts of trafficking cocaine.**

Police reported filing about 50 charges against other people stopped at the checkpoint. Charges ranged from driving while impaired to driving with a revoked license to possession of moonshine.

Police and law enforcement officers from several Johnston County towns and agencies participated in the checkpoint operation.

## **28 Accused in Alleged Honduras-to-Virginia Drug Smuggling Ring**

Federal authorities arrested 28 people and charged them with participating in a cocaine-smuggling ring that brought millions of dollars in drugs from Honduras to northern Virginia over the past six years.

Court records indicated that **many of those arrested were illegal immigrants** living in northern Virginia.

The smugglers would bring in several pounds of cocaine at a time by hiding it in common items like shoes and wooden frames on flights from Honduras to the United States.

## **The drugs allegedly were distributed to dealers in Virginia, Maryland, North Carolina and Massachusetts.**

Members of the ring allegedly wired more than \$1 million from the U.S. back to suppliers in Honduras.

The investigation began in the fall following the arrests in Fairfax County of Lindor Delis Martinez-Guevara, aka Lindo or Genero, 38, of Falls Church, and Melcy Yalexsy Guevara-Barrera, aka Pedro or Primo, 35, of Vienna, according to the affidavit. They -- along with Samuel Benitez-Pineda, aka Wilfredo Benitez or Roque or Chiripa, 34, of Arlington, and Jose Fredy Delcid, aka Oscar Salgado or Oscar or Franklin or Chami or Matador, 34, of Falls Church -- had contact with the suppliers in Honduras, authorities said. Martinez-Guevara came up with the idea of hiding the drugs in frames, according to the affidavit.

**Deputies said they found counterfeit social security cards at the time of her arrest.** Authorities said the identity and location of the second victim currently remains unknown.

Mendez has a June 4 court date in Lexington. The investigation is ongoing.

## **Driver charged with hit-and-run that injured 2 children, 2 others**

DURHAM – Four people were injured, one critically, in a hit-and-run accident late Wednesday on the Roxboro Street off-ramp from Interstate 85 North. The driver of the hit-and-run vehicle, **Oscar Jaramillo Perez**, 26, of Constance Avenue in Durham, was later located and arrested.

He was released Thursday from the Durham County Jail on \$15,000 bail.

The accident was reported at 11:52 p.m. Wednesday, police spokeswoman Kammie Michael said. A Dodge pickup truck crashed into the back of a Honda Accord, which was out of gas on the ramp.

The Accord was occupied by a woman and young children, ages 1 and 3. The 1-year-old child, who was in a car seat in the back seat of the Honda, suffered critical injuries and is being treated at Duke University Hospital. The woman and 3-year-old child, who were in the front seat of the Honda, were treated for minor injuries.

The pickup truck was occupied by a driver and two passengers. The driver and one passenger jumped and ran. The other passenger – a female – was injured and taken to the hospital for treatment.

Officers searched the area and found Perez, who was identified as the driver of the pickup truck. He was **charged with driving while impaired and felony hit-and-run.**

## **Woman hit, killed by van in Cotswold; driver charged**

CHARLOTTE, N.C. -- The driver of a van that struck and killed a woman walking with her husband at a Cotswold intersection Wednesday morning has been charged and arrested.

Marianne Oberg, 62, was hit by a white van making a left turn at the intersection of North Sharon Amity Road and Addison Road shortly before 10 a.m. Wednesday. Oberg was rushed to a nearby hospital but died about five hours later, though her husband was not hurt.



The driver, 20-year-old **Kelvin Alexis Garcia Guardado, was arrested Wednesday night and is charged with misdemeanor death by motor vehicle.**

Officials said speed and alcohol were not factors in the incident.

## **Sheriff's search for police chase suspect**

BURLINGTON, N.C. – Authorities are searching for a third suspect involved in a police chase in Alamance County.

According to Alamance County Sheriffs, **Carlos Fabian Perez**, 35-years-old from Graham, **is wanted for possession of marijuana, drug paraphernalia and resisting arrest.**

According to Sherriff's, Perez and two other suspects, Jarvis Lee Johnson, 39 of Mebane and Jerrold Lee Brown, 37 of Maybrook Drive in Greensboro, lead authorities on a police chase through Burlington around 5:30 p.m. after a routine traffic stop.

During the pursuit, Johnson, the driver of the vehicle, rammed into a sheriff's patrol car on Delaney Drive and lost control of his vehicle.

Johnson then turned onto Delaney Court, where all three suspects fled the scene on foot.

Gibsonville K-9 units responded to the scene and assisted in the arrest of Johnson and Brown.

Johnson was charged with assault with a deadly weapon, felonious fleeing to elude arrest, and related charges. Brown was charged with possession of marijuana and drug paraphernalia, along with resisting arrest.

## **Granville County cockfighting ring busted**

GRANVILLE COUNTY (WTVD) -- Authorities busted an illegal cockfighting ring in Granville County Sunday morning.

Twelve people were arrested, and officials seized 63 roosters, \$23,000 in cash, and one gun during the investigation.

Sgt. Chad Coffey with the Granville County Sheriff's Office said they discovered the location off Highway 96, near the Tar River, almost by accident.

"We were doing a joint interdiction on 1-95 with other agencies around the state, a vehicle was stopped for a traffic violation and in the vehicle were several fighting roosters," Coffee said.

From there, an undercover officer followed the vehicle to the location of the illegal operation.

"Officers drove back here to where the cockfighting was taking place and 15-20 guys ran," Sgt. Coffee said.

Authorities were able to take some of the suspects into custody immediately.

While searching for the others, officials said they found various paraphernalia, including scales used to weigh the birds, record books with results of previous fights, and spurs that are attached to roosters' legs during the fights. There was also a scoreboard set up on the property that would be used during a match.

Cockfighting is a felony, but officers told ABC11 that it is sometimes hard to catch criminals in the act because it is not illegal to own or breed roosters, only to fight hold fights.

"The fights are to the death, so the loser is the one that dies, the winner is the one that lives, but often times when these fights are over, the winner will die himself because of injuries sustained during the fight," Sgt. Coffey said.

**Officials said all 12 suspects were charged with cockfighting. Authorities said many of those in custody were illegal immigrants and will face deportation in addition to the cockfighting charges.**

## **ICE arrests 32 illegal immigrants in North Carolina**

Federal authorities say they arrested 80 illegal immigrant criminals in Georgia and the Carolinas during a three-day "Cross Check" operation this week.

**All of them had criminal convictions, including violent offenses such as aggravated assault, family violence and sexual battery of a minor**, according to U.S. Immigration and Customs Enforcement. ICE declined to identify them but said most were arrested in the Atlanta area.

ICE officials arrested 33 in Georgia, **32 in North Carolina** and 15 in South Carolina. They came from Mexico, Guatemala and the Dominican Republic. ICE is holding them pending removal -- or deportation -- proceedings.

## **1-year-old critically injured in Durham hit and run**

DURHAM, N.C. — A 1-year-old child was critically injured in a hit and run while sitting inside a car that had run out of gas late Wednesday on Interstate 85 in Durham.

Police said Thursday that a Dodge pickup truck crashed into the back of the Honda Accord, which was parked on the Roxboro Street off-ramp from northbound I-85 around 11:50 p.m.

The child, who was in a car seat in the back of the Honda, was being treated at Duke University Hospital Thursday.

A woman and a 3-year-old child who were in the car were also treated for minor injuries.

Authorities did not release their names.

The pickup truck's driver, **Oscar Jarmillo-Perez**, 26, of Constance Avenue in Durham, was **later arrested and charged with driving while impaired and felony hit-and-run.**

Police said that, after the crash, the driver and another person in the truck jumped and ran. A third passenger was taken to a local hospital for treatment.

The exit ramp from I-85 North to North Roxboro Street was closed for several hours overnight while investigators took measurements and tried to determine a cause of the wreck

## **Two charged with stealing more than \$4,000 worth of bras from Victoria's Secret**

**Two Cary residents from Colombia have been arrested and charged with identity theft and larceny of more than \$4,000 worth of bras from Victoria's Secret.**

The pair have also been charged with stealing more than \$2,000 worth of cologne from a cosmetics store, Ulta, according to arrest warrants filed by Cary police.

**Jeiner Leonardo Ocampo Quintero** and **Maria Del Carmen Martin Pozo** were arrested Friday, according to the warrants.

Police launched the investigation when they smelled marijuana smoke coming from a room at Motel 6 on Buck Jones Road in Cary. When they entered the room, they found many items that appeared to have been stolen, said Cary police spokesman Mike Williams.

**Quintero and Pozo both used false identities during the initial drug investigation, according to the warrants. Quintero was accused of two counts of identity theft, since he possessed numerous California driver's licenses that belonged to others.**

**Both have been placed under an immigration detainer while the Department of Homeland Security determines whether they will be removed from the United States.** It is unknown how long they had been staying in Cary, but the two told police they recently flew in from Los Angeles, according to Williams.

Each is now being held under a \$50,000 bond in the Wake County jail.

## **30 charged after 2 months of undercover drug buys**

The Wilkes Sheriff's Department is in the process of arresting the last of 30 people charged with various felony offenses in the department's latest undercover drug roundup.

Lt. Craig Dancy, who heads the sheriff's department's narcotics unit, said the charges resulted from over two months of mostly unrelated investigations in which undercover officers bought cocaine, marijuana, prescription drugs and methamphetamine (meth).

Dancy said the latest investigations, involving the sheriff's department's entire narcotics unit, were concentrated on locations all over Wilkes.

Although most of the 30 people are believed to be street level drug dealers, he said, some of them came from other area counties to sell in Wilkes.

Among the 30 people charged, he said, the two identified by investigators as the largest suppliers of cocaine were Grant Eugene Cowles, 42, of Parks Ridge Road, North Wilkesboro, and **Miguel Valerio**, 27, of Beck Court in Boone.

Dancy said over an ounce of cocaine was seized when Cowles was arrested. Cowles is charged with trafficking in cocaine, possession with intent to sell and deliver cocaine, maintaining a dwelling for keeping a controlled substance and possession of drug paraphernalia.

**He said the investigation of Valerio led to the arrest of Valerio's supplier and the seizure of 16 pounds of meth in another county. Dancy said investigators believe Valerio, charged with possession with intent to sell and deliver cocaine and sale of cocaine, was trading cocaine for prescription pills in Wilkes.**

He said charges against **Antonio Tovar-Perez**, 47, and **Miguel Tovar-Vidal**, 23, who shared a residence on Summerville Place in Wilkesboro, are related. They're **both charged with sale of cocaine and possession with intent to sell and deliver cocaine. Tovar-Perez is also charged with sale of prescription medication and possession with intent to sell and deliver prescription medication.**

Other people charged in the latest undercover cases include:

- **Gil Perez**, 28, of South Cherry Street, Wilkesboro, **possession with intent to sell and deliver prescription medication and sale of prescription medication;**
- **Alirio Rodriquez Castro**, 24, of Beehive Drive, Moravian Falls, **four counts each of possession with intent to sell and deliver cocaine and sale of cocaine, as well as one count of conspiracy to sell cocaine;**
- **Alejandro Mendoza Ortiz**, 35, of Zacks Street in Millers Creek, **sale of cocaine and possession with intent to sell and deliver cocaine;**
- **Jose Tomas Ibarra-Paz**, 48, of Luck Circle, North Wilkesboro, **sale of meth, sale of prescription medication, possession with intent to sell meth and possession with intent to sell prescription medication;**

Dancy said more arrests and more charges are expected as investigations related to this latest roundup continue.

## **4 Sentenced To Prison For Attempted Drug Trafficking**

Four men have been sentenced to prison after being caught last November with cocaine with a street value of \$70,000. The narcotics were found by drug agents with the Johnston County Sheriff's Office who raided a home on Sunray Drive outside of Clayton.

## **1,500 pounds of pot found in tractor-trailer at Charlotte warehouse**

Six men are facing federal drug charges after authorities said they discovered a tractor-trailer with 1,500 pounds of marijuana at a northern Charlotte warehouse.

On Thursday, authorities received information that a tractor-trailer carrying the drugs would arrive at a hotel on Sunset Road off Interstate 77 in Charlotte, according to an indictment filed in U.S District Court.

Drug Enforcement Administration agents set up surveillance in the area, the indictment says, and around 1:40 p.m. Thursday, agents spotted the vehicle – an 18-wheeler with a refrigerated trailer.

Agents said they also saw suspects at a nearby Days Inn on Sunset Road.

After several hours of surveillance and following suspects around the area, authorities watched as the tractor-trailer arrived at a warehouse on Old Statesville Road near West W.T. Harris Boulevard, according to the indictment. Authorities said the warehouse is known as a drop-off point for large loads of marijuana.

Then, agents said, they saw several men in and around the trailer and heard the sounds of heavy objects hitting the floor. Authorities moved in to arrest the men, who tried to flee.

Inside the tractor-trailer, authorities found 125 plastic-wrapped bales of marijuana totaling 1,500 pounds, the indictment says. A van driven by one of the suspects had another 60 bales of marijuana – about 700 pounds. One suspect told authorities that the drugs had been driven to Charlotte from Texas.

## **ICE at checkpoint identifies 15 illegal aliens**

TUCKASEGEE — The Hispanic community in Jackson County is frustrated and confused after the Sheriff's Office requested the involvement of U.S. Immigration and Customs Enforcement in a traffic checkpoint this month.

Vincent Picard, southern region communications director and spokesman for ICE, said the seat belt checkpoint in question is part of a statewide campaign under the N.C. Governor's Highway Safety Initiative.

"While the principal purpose of these campaigns is to increase seat belt and child safety seat usage, it also often results in the identification of criminal violators," he said. "As a law enforcement agency, ICE regularly works with our city, county and state partners in operations that enhance public safety."

**ICE identified 15 foreign-born individuals who did not possess proper immigration documents to be in the country legally**, Picard said. The criminal convictions of the arrested persons ranged from multiple traffic

violations and DUI offenses to domestic violence, ICE said. **Authorities identified two people who had been previously deported from the U.S. and re-entered illegally**, Picard said.

The 15 individuals were taken into ICE custody and transported to Charlotte. Picard said 12 of the 15 arrested were released under Orders of Recognizance or placed into the Alternatives to Detention (ATD) program. The remaining three were booked into custody and detained by ICE.

## **Police seek witnesses in fatal Charlotte wreck**

A 24-year-old man remains in jail on Wednesday charged in a fatal wreck earlier this month in west Charlotte. Meanwhile, police are asking anyone who witnessed the wreck to come forward.

**Luis Federico Medina is charged with reckless driving and involuntary manslaughter**, Charlotte-Mecklenburg police said Wednesday. Medina is being held in the Mecklenburg County jail, and **records show an immigration hold has been placed on him**.

Police said Medina was driving in the 7200 block of Bellhaven Boulevard on May 1 when he crossed the double yellow line and drove into oncoming traffic. He then crashed head-on into a vehicle driven by Carlleena Ieasha Person, police said.

After the wreck, police said Medina fled the scene by foot but was caught a short time later. He was charged initially with felony hit and run and driving without an operators license.

Person, 32, succumbed to her injuries on May 20, and authorities took out additional charges against Medina.

Police said neither speed nor alcohol was a factor in the wreck.

CMPD's Major Crash Investigation Unit is still looking into the wreck. Anyone who witnessed the wreck is asked to call Detective Kevin Allred at 704-336-8862.

## **Murder charge filed in Gaston DWI death**

A Charlotte man faces a second-degree murder charge after reportedly running over his friend with a truck while intoxicated in Mount Holly, according to police.

**Sybounreuang Keonakhone**, 50, of 427 Hillcrest St., was **initially charged with driving while impaired but now faces a murder charge** in the death of 60-year-old Somvang Thanoulith of 7214 Tuckaseegee Road, Charlotte.

Mount Holly police responded to the Asian Market, 605 E. Charlotte Ave., at 10:46 p.m. Saturday to find Thanoulith in the far right corner of the parking lot.

A Dodge Dakota pickup driven by Keonakhone hit Thanoulith, according to Capt. Jim Benfield with Mount Holly Police Department.

Keonakhone reportedly told Thanoulith that he was too intoxicated to drive the pickup at the Asian Market, which sells Asian foods, herbs and spices, according to Benfield.

Thanoulith suffered head trauma and was transported to Gaston Memorial Hospital, then airlifted to Carolinas' Medical Center in Charlotte. Benfield said he was notified on Tuesday morning that Thanoulith died around 9 p.m. Monday.

Police interviewed a woman who runs the Asian Market, questioning her through a family member who speaks English, in an effort to gain more information on the incident.

"Both men arrived together and apparently there was some type of altercation or argument in the parking lot," Benfield said. "The next thing she knows, the passenger of the truck was run over in the parking lot."

Police still don't know what exactly transpired between the two men in the parking lot or why Thanoulith was outside of the truck.

Keonakhone also struck a Dumpster, fence and utility pole in the parking lot, according to police.

Upon learning of Thanoulith's death, police consulted with the Gaston County District Attorney's Office and Keonakhone was charged with second-degree murder. He also faces charges of DWI and failure to comply with restrictions on a license.

Keonakhone is being held at the Gaston County Jail under a \$1 million secured bond.

## **Boyfriend arrested after woman's body found in car beside road**

GUILFORD COUNTY, N.C. - Guilford County Sheriff BJ Barnes said Thursday that a Greensboro man has been arrested in connection with the death of his girlfriend, whose body was found one week ago in an abandoned car in McLeansville.

**Miguel Melo Nolasco**, 32, of 914 Rucker St., **was arrested in connection with the death of Glenda Carolina Magana-Jiron, 25, of Hickory.**

Magana-Jiron's body was discovered around 9:45 a.m. on May 24 in a silver Oldsmobile Alero that had been left on the side of Huffine Mill Road near the intersection with Camp Burton Road.

"The victim's death was due to a laceration to the neck by a cutting instrument and a stab wound to the upper left chest area," the sheriff's department said in a press release.

While Barnes said the suspect and victim were seeing other, he said both were also married to other partners. They also each had some type of history related to drug charges, Barnes said.

Magana-Jiron's husband, who was not named, is currently in jail on unrelated drug charges, Barnes said.

About seven hours before her body was discovered, deputies said Magana-Jiron was seen leaving Garibaldi's Mexican American Restaurant at 3109 Summit Ave. in Greensboro.

Barnes said the department has received significant assistance from the Hickory and Greensboro police departments and the federal Division of Immigration and Customs Enforcement.

"Sheriff Barnes would also like to thank the Latino community for their assistance in solving this case. The citizens have been forthcoming and have been very cooperative," the release states.

The investigation is continuing and anyone with information is asked to contact the Guilford County Sheriff's Office at 336-641-3690 or Crime Stoppers at 336-373-1000.

Rivarra fled in a black 1996 Acura, with a South Carolina license plate of GLP 376.

## **Men sentenced to prison for selling fake IDs in Asheville area**

ASHEVILLE — Three men who produced and sold counterfeit Social Security cards and other fake identification documents in Buncombe and Henderson counties have been sentenced to federal prison.

**Angel Evilio Alvarado-Gonzalez, Salimon Ramos and Herbert Alexander Guevara-Alvarado** were snared in an undercover operation, according to court records.

Creating fake IDs can put the public in danger, said Brock Nicholas, an investigator with U.S. Immigration and Customs Enforcement.

“Anyone who knowingly and indiscriminately sells fraudulent identity cards is putting the security of our communities and even our country at risk, as counterfeit documents can potentially be used by dangerous criminals and others who are attempting to obscure their identities and cover their tracks,” he said.

**Alvarado-Gonzalez, 32, of Honduras, and Ramos, 34, of Mexico, were each sentenced in U.S. District Court in Asheville to 30 months in prison. Guevara-Alvarado, 32, of El Salvador, was sentenced to 13 months time served.**

**The three defendants, who lived in the Asheville area before their arrests in March 2011, are undocumented immigrants who were ordered by the court to be deported upon completion of their sentences, court records state.**

At Ramos’ sentencing last week, defense attorney Jack Stewart urged Judge Martin Reidinger to sentence him to time served. Stewart said Ramos wasn’t the ringleader of the counterfeiting scheme and would be deported and wouldn’t return.

Reidinger declined.

“It was a crime of helping people thwart the law,” the judge said. “It’s a serious crime.”

According to court documents, Alvarado-Gonzalez told investigators that Ramos produced about 80 sets of fake identification documents at a residence on Rock Hill Circle in Asheville using a computer, scanner, printer and other materials.

## Motel Clerk Among 6 Charged In Marijuana Bust

## **Tip leads to arrest of robbery suspect**

A tip to police has led to an arrest in the March armed robbery of a store on West Pine Street.

Before that new information recently was received, the investigation of the March 15 crime at La Tapatia No. 3 basically had gone "cold," Mount Airy Police Chief Dale Watson said Tuesday.

But the tip led to **Ricardo Covarrubias**, 17, of 146 Marlin Way, being developed as a suspect in the robbery, in which a man entered the store during the evening hours, pointed a pistol at a cashier and demanded money.

He took an undisclosed sum of cash from the register and fled on foot from the store at 936 W. Pine St., which caters to the Hispanic population. No injuries occurred to anyone inside the business.

Despite an exhaustive search of the area surrounding that location by both city police and Surry County deputies as well as a tracking dog, the gunman managed to escape.

At the time, there was speculation that the robber, described only as a Hispanic male wearing a black hoodie-style sweatshirt, might have been picked up by an accomplice or had a vehicle waiting.



With all leads surrounding the armed robbery having been exhausted, the investigation had hit a lull before the tip was received, according to the police chief.

He declined Tuesday to specify the information involved, explaining that the person who supplied it fears retaliation.

However, the establishment of the robbery's possible link to Covarrubius paved the way for police to interrogate the man, which led to his confession. Watson added that Covarrubius had no previous criminal record.

Covarrubias was arrested at the Mount Airy Police Department and held under a \$10,000 secured bond in the Surry County Jail. He is scheduled to appear in District Court in Dobson on Monday.

The March incident was the second armed robbery of La Tapatia No. 3 within a year. Two Hispanic males who escaped in a waiting vehicle were involved in the first incident on May 13, 2011, which remains unsolved.

## **Man wanted in hatchet attack arrested in Wilmington**

Polanco-Osorio and Brice, both from Charlotte, were arrested Wednesday and remained in Mecklenburg jail Thursday. They face **armed robbery charges**.

Police said they searched the apartment where Brice was arrested and found the gun believed to have been used in both robberies, as well as stolen property belonging to the victims.
