## Winston-Salem License Plate Agency Closed For Audit

The N.C. Division of Motor Vehicles closed the license-plate agency in the West Salem Shopping Center yesterday after one of the agency's former employees was arrested on fraud charges.

**Zoyla Bustos-Perez**, 28, of 3001 Marmion St. was charged with misapplication of government property, obtaining state vehicle titles by false pretense, and accessing state government computers to defraud the state of North Carolina.

Busto-Perez was **in the country illegally**, said Barbara Gonzalez, the southern regional communication director for U.S. Immigration and Customs Enforcement.

Benjamin F. Joyce and Jarret Henry Joyce have run the office, which is on Peters Creek Parkway since 1993. They are under investigation by the immigration agency over whether they knowingly hired an illegal immigrant.

No charges have been filed against the owners, officials said.

The investigation into the agency started about nine months ago, said Margo Howell, a spokeswoman for the DMV.

License-plate agencies offer vehicle-registration services, title transactions, vehicle-license renewals, replacement license plates and duplicate registrations, according to DMV. There are about 120 license-plate agencies across the state. They are typically operated by contractors, such as the Joyces.

According to arrest warrants, the alleged offenses involving Bustos-Perez started on Nov. 11, 2000.

## Two Indicted In Murder Investigation

Two men have been indicted by a Grand Jury in connection with the murder of a Benson man in July. The body of 34 year-old Uristegui Calderon of West Harnett Street, was found in a ditch on Glendale Road near Highway 222 West of Kenly on August 1.

Johnston County sheriff's investigators believe he was killed at another location in northern Johnston County on July 30 and his body was later dumped along the rural roadway.

On Monday, a Grand Jury formally indicted 18 year-old **Diego Carajal Reyes** and 17 year-old **Francisco Javier Zuniga**, both of Middlesex for the crime. Reyes was indicted for the murder. Zuniga was indicted as an accessory after the fact. Indictments allege Zuniga helped clean up the crime scene, dispose of the victim's body, and also burn his car. A motive for the slaying has not been released.

## Shootout injures Durham vice-squad officer, suspect

**DURHAM, N.C.** — A vice-squad officer and a suspect were injured in a shootout outside a Cracker Barrel restaurant, 3703 Hillsborough Road, off Interstate 85, in Durham Wednesday evening, authorities said.

Gunfire erupted after the vice-squad officer tracked a couple of men to the restaurant's parking lot during a narcotics investigation at about 7:30 p.m., said Lt. Stan Harris, of the Durham County Sheriff's Office. Bullets struck vice-squad officer Morial S. Whitaker and suspect **Olvin Alexander Aranda Hernandez**, Harris said.

Hernandez, 24, of 1506 Bungalow Ave.; **Victor Oscar Olguin-Bravo**, 21, of 917 Virgie St.; and **Richanel Sala Sala**, 19, of 2816 Ross Road Apt. 10-G, were taken into custody and face drug trafficking charges. Authorities said they found 614 grams of cocaine on the men.

Hernandez is also expected to be charged with assault with a deadly weapon with intent to kill inflicting serious injury, possession of a firearm by convicted felon, assault on a government official by firearm and armed in the terror of the public for firing a gun in the restaurant's parking lot.

A Catawba County man accused of taking a local teen to Illinois will face his charges in McDowell County Superior Court.

On July 13, a grand jury returned 76 true bills of indictment. The panel indicted 25-year-old **Edgar Escalerra Soto** of Hickory on one count of second-degree kidnapping and four counts of taking indecent liberties with a child.

Soto is accused of fleeing to the Chicago area with a local 15-year-old girl in mid-June.

Information about the two of them was entered into a nationwide crime database and on the National Center for Missing and Exploited Children's Web site.

A week later, officers with the Orland Park Police Department in Illinois spotted Soto's truck at a hotel.

They took Soto into custody, and he eventually led them to an apartment in a neighboring county, where they found the missing teen unharmed.

**CLINTON** - Lawmen found 251 pounds of marijuana valued at \$1.135 million Tuesday when a drug-sniffing dog alerted on a transformer being hauled in a truck in northeastern Sampson County.

Lawmen stopped the truck on Grimes Road in the Suttontown community about 2p.m., according to a news release from the Sheriff's Office.

Investigators had been keeping the man driving the truck, **Anselmo Diaz-Perez**, 19, of the 100 block of Red Ranch Lane in Faison, under surveillance since August, the release said.

Investigators had the dog search the vehicle and it alerted on the transformer, which was packed in a plywood crate, Pope said. A search of the crate turned up 21 bales of marijuana.

Perez is charged with trafficking marijuana by possession and by transport, possessing marijuana with intent to sell and deliver and maintaining a vehicle for the sale or storage of a controlled substance.

Bail was set at \$155,000.

**Luis Eduardo Escobar's** court proceedings ended in a mistrial after jurors were unable to reach a unanimous decision about his alleged sexual crimes against a girl.

Under state law, if Durham law-enforcement officials can't determine the country of origin for inmates, then immigration officials have to take custody of those inmates, Martin said. The inmates receive hearings to determine whether or not they're allowed to remain in the United States, he said.

Escobar was indicted on two counts of statutory sexual offense, two counts of sexual activity by a substitute parent and two counts of taking indecent liberties with a child. After the state's evidence was presented, the court dismissed the charges for statutory sexual offense and sexual activity by a substitute parent.

Five Hispanics believed to be here illegally face charges of bribing a Gaston County driver license examiner with \$300 to get a driver's license, according to arrest warrants and affidavits.

DMV inspectors arrested **Claudia Morales Rodriguez**, 29, and **Alfredo Lopez Hernandez**, 29, both of Gastonia, and **Juan Alberto Goddy Vasquez**, 37, of Kings Mountain on charges of attempting to bribe a state driver license examiner to obtain a driver's license.

All three are believed to be in the country illegally, according to the DMV. They were placed in Gaston County Jail under \$10,000 bonds Monday. Their release remains on hold by Immigration and Customs Enforcement pending a review of their immigration status, according to Gaston County Sheriff's Office.

The arrests stem from an investigation of a document lab that had equipment and materials to manufacture counterfeit resident alien cards, Social Security cards, birth certificates and driver licenses from six states, according to a release from the Department of Motor Vehicles.

DMV inspectors also arrested **Mario Ziranda**, 35, and **Elvis Sanchez**, 28, at their residence at 272 Roberson Lane, Forest City. They face charges of common law forgery, manufacturing North Carolina driver licenses, felony trafficking of identification documents, possession and delivery of cocaine and misuse of vital records.

Searching the Forest City residence revealed ledgers showing hundreds of fake document sales weekly, according to the release. Driver licenses from California, Florida, Tennessee, Texas, Ohio and North Carolina were found at the location, along with Social Security cards and a Maryland birth certificate. Investigators also seized \$8,000 in cash and 15 grams of cocaine.

Sanchez has no legal United States documentation, according to the release. They are being held on \$75,000 secured bond in Rutherford County Jail.

**Ramon Rodriguez Pena**, 34, sent the teen in to purchase a Shop-Vac from the store but more than a vacuum cleaner was inside the box, the affidavit narrative states.

According to the report, three Hispanic women came into Wal-Mart about 3 a.m., opened the item, placed printer cartridges and clothing inside, taped the box closed and put it back on the shelf. A loss prevention officer watched surveillance video of the incident, the narrative states.

Management watched the item until it was purchased and contacted Cherryville Police, according to the report. The girl was followed outside to the car where Pena was waiting.

Pena was charged with felony larceny and contributing to the delinquency of a juvenile. He was held on a \$10,000 secured bond.
