In June 2011, Cruz was at a public pool owned by the city of Eden while children were present. According to the release, complaints were made to the pool staff and they confirmed Cruz was a sex offender. Cruz admitted to authorities he was not allowed on the premises, according to police.

Santiago is also now the subject of a federal immigration detention order issued by the Department of Homeland Security that states he is from Mexico.

He is being held under a \$600,000 bond. He is accused of first degree rape and first degree kidnapping.

GRAHAM, N.C. — A North Carolina man who fathered two children with **a girl he kidnapped when she was 13** has been sentenced to at least 20 months in prison.

The Times-News of Burlington reports that 33-year-old **Mendoza Maldonado** pleaded guilty Monday. Prosecutors say the girl ran away from her home in Graham in 2006 to live with Maldonado, who took her to Florida, Georgia and Texas.

When she returned to Alamance County in 2009, she had one child and was pregnant with another. Maldonado was arrested two years later, after returning to North Carolina.

Maldonado will be deported to Mexico once his sentence is finished. The girl is now 18 and refused to testify against him and plans to follow him to Mexico when he's released.

A 35-year-old south Charlotte man has been charged with statutory rape after **a 14-year-old girl** gave birth to his child this weekend, according to police.

Jail officials say **Juan Martinez Hernandez**, who is believed to be in the country illegally, has run afoul of police and immigration agents before, following a 2010 drunken driving arrest.

It's unclear what became of Hernandez between his release to immigration agents in 2010 and the rape charges on Sunday. Immigration and Customs Enforcement officials couldn't be reached for comment Monday.

On Sunday, the 14-year-old gave birth to a baby in the bathroom of an apartment off Mont Carmel Lane near East Arrowood Road.

Her family called 911, and the responding paramedics asked police for assistance. The girl told police the baby's father was a man who lived in the neighborhood, and Charlotte-Mecklenburg police found and interviewed Juan Martinez Hernandez.

Hernandez "admitted to engaging in sexual intercourse with the victim on several occasions," according to a police report.

Hernandez was charged with four counts of statutory rape and two counts of indecent liberties with a child. He is in jail at the Mecklenburg County Sheriff's Office under a \$250,000 bond.

### **Child rapist will not face charges thanks to I.C.E. policy**

Two weeks ago, **Juan Carlos Santos-Hernandez** was sitting in a Forsyth County jail cell after being charged with three felonies in connection with the molestation of **a 10-year-old girl**.

A written plea offer prepared by prosecutor Kia Chavious spelled out the likely path for the 21-year-old: Plead guilty and the state will agree to let you be sentenced for one felony instead of three. You might get out in 25 years. Wait much longer or take your chances with a jury, you may die behind bars.

Now that's moot, thanks to an ill-advised policy being followed by the U.S. Immigration and Customs Enforcement Agency. Within a week or two, Santos-Hernandez could be lying on a beach in Acapulco, a free man sipping cervezas in Mexico.

"He very well may get a pass on these charges," Chavious said in court last week. "(ICE) understands our position, but there is no mechanism to stop it. Once the ball is rolling, nothing is going to stop it."

Road map to a loophole

As one might expect, the story of how a person charged with child molestation can get a get-out-of-jail-free card from the federal government involves more than a few twists.

Santos-Hernandez, whose last known job was a cook for a Winston-Salem chain restaurant, was arrested in October on one count of taking indecent liberties with a child. He went to jail and had bond set at \$100,000. He stayed there while investigators continued to look into the allegations.

In early March, a grand jury indicted Santos-Hernandez on two additional felony counts - including the more serious charge of committing sex offense with a child that carries a mandatory 25-to-life sentence.

As is typically the case in crimes involving illegal immigrants, the federal government had issued a "detainer" on Santos-Hernandez. That means the minute he walked out of jail, he was subject to be deported.

What happened next defies common sense.

The scheme was outlined in court documents and in an "order for arrest" motion that Chavious argued Wednesday - a last-ditch legal maneuver that basically says Santos-Hernandez was never formally charged with the new crimes and needs to be brought back.

On March 22, Santos-Hernandez posted bond and left the county jail. (Because Santos-Hernandez technically did not flee custody willingly, his bond likely will not be forfeited.)

Predictably, ICE snatched him up and sent him to a federal detention facility in Georgia. It happened so fast his own lawyer didn't even know he had left the local lockup.

And because he waived his rights, Santos-Hernandez was put on the fast track for deportation. Goodbye, prison. Hola, Mexico.

"It looks like he's using voluntary deportation as an escape hatch," Superior Court Judge Ron Spivey said to Chavious during the hearing. "Is that your concern?"

"It's something they're all looking into doing," Chavious said. "Post bond and trigger that 48-hour response (from ICE), then waive their rights. They're back home in a week or shortly thereafter."

Prosecutors say at the time of the crime, Sanchez was in the United States illegally. Assistant District

Judge Ola Lewis sentenced Sanchez to 12 to 15 years in prison. Sanchez will also be required to complete sex offender treatment in prison, register as a sex offender and be subject to GPS satellite monitoring for the rest of his natural life.

As a result of his status as an illegal alien, the United States Office of Immigration and Customs Enforcement (ICE) has placed an immigration detainer on Sanchez, which requires his deportation from the United States, but that will only occur after he has served his entire active prison sentence in the United States.

RALEIGH (WTVD) -- A former Wake County man already in jail now faces more charges for allegedly taking video of young girls in the shower.

**Porfirio Fregoso**, 42, is in jail in Durham **charged with first degree rape**. Fregoso was already under a bond of more than \$1.6 million stemming for **the rape charges and three counts of indecent liberties with a child**.

Thursday, he was hit with new peeping charges. Those charges, according to court records, involve a house in Holly Springs where Fregoso used to live with his girlfriend.

Neighbors said the couple recently moved to Durham, which is where he was first charged with rape and indecent liberties.

Holly Springs police also hit him with indecent liberties charges earlier this month. Then, over the weekend, detectives said Fregoso's girlfriend found a cell phone with video of underage girls showering at the house in Holly Springs.

Now, Fregoso faces five more charges of felony secret peeping.

It's not clear when or if Fregoso will show up at the Wake County courthouse.

Since the most serious charge of rape was filed against Fregoso in Durham, he will most likely remain in jail in Durham for at least for the time being.

MORGANTON - Police on Tuesday charged the Morganton man accused Sunday of taking indecent liberties with a child with a second sexual offense.

His first appearance in court will be Aug. 6.

### Teen girl raped, shot, left in river by illegal aliens

LILLINGTON, N.C. (WTVD) -- On Sunday, Harnett County sheriff's deputies arrested **Jose Trinidad Soto Sanchez**, 21, and **Jose Juan Alvarez**, 28, after they reportedly **raped a 17-year-old girl and shot her multiple times**.

The girl was discovered lying in the Cape Fear River near the North Carolina Highway 217 bridge near Erwin, bleeding and left for dead.

Sheriff Larry Rollins told WTVD:

"They had abducted her from her house where she was babysitting her 3-year-old sister. From there we understand now she was taken to the river where she was sexually assaulted. After the sexual assault had taken place, she was shot three times."

The victim, who was shot in the face, abdomen, and hand was initially taken by helicopter to Betsy Johnson Memorial Hospital in Dunn and later transferred to UNC Hospital in Chapel Hill.

Both **Sanchez and Alvarez have been charged with first-degree rape, first-degree kidnapping, and attempted murder**.

They are currently being held at the Harnett County Detention Center on immigration detainers.

The two Mexican nationals live together in Spring Lake.

TARBORO, N.C. — A **2-year-old child beaten beyond recognition** at a babysitter's house in Tarboro earlier this month **was also sexually assaulted**, authorities said Tuesday, after charging two people in the attack.

**Cirilo Torido-Bastida**, 41, of Macclesfield, faces **two counts of first-degree forcible sex offense and one count of assault inflicting serious bodily injury**. He was placed in the Edgecombe County jail Tuesday under a \$855,000 secured bond.

Chelsey Elane Speight, 20, of Tarboro, was charged with accessory after the fact on all three counts and placed in the Edgecombe County jail under a \$355,000 secured bond.

Investigators say Speight was watching two children for a friend the night of Nov. 3. When the mother returned, her 2-year-old had been savagely beaten but the other child was unharmed.

The mother said the injuries were so severe that she didn't even recognize her own child. She also said Speight told her a dog had attacked the child.

Speight, of 374 Northwoods Country Road, was initially arrested Nov. 4 and charged with felony child abuse and misdemeanor child abuse. She posted \$1,500 bond and returned home.

But medical examinations confirmed the extent of injuries to the child, who has since been released from the hospital and is recovering at her grandmother's house, leading to the new charges against Speight.

No other information was released. The relationship between Speight and Torido-Bastida was not disclosed.

Cary Academy Director of Advancement Lynne Fountain said in a news release the alleged victim - while a minor - is not a current or former Cary Academy student. According to Cary investigators, the **victim is a 14-year-old boy**.

The victim's father was the first to call 911. He was with the child waiting for his mother to get off work. The mother is believed to be a contract worker at the school.

In the 911 call, the father told the operator that his son went inside the gym to use the bathroom, and the suspect, 36-year-old **Alfredo Martinez Lopez**, went inside the bathroom with the child and molested him. "As soon as this became knowledgeable to us police were called. Police immediately started talking to the alleged victim," Fountain said.

Fountain said an arrest warrant has been issued for a contract worker from a local cleaning company.

"We would like to put other parents fears at ease and let me them know that, obviously, take the normal precautions you would with your children. But we have no reason to believe he's going to return there or return to another school to commit a similar act," Cary Police Captain Don Hamilton said.

"When we are dealing with an outside company like we were with this company background check were done. And we have background checks on file," Fountain said.

"I am saddened that this alleged incident took place on our campus," said Head of School Mitch McGuigan in a statement. "Our concern is for the alleged victim and the family."

Upon his arrest, Lopez will be **charged with three counts of statutory sex offense** and, if convicted, will face up to 16 years in prison.

Aguilar still remains in the Johnston County Jail under a \$400,000 bond.
