CHARLOTTE, N.C. - Police in Charlotte are investigating after <u>a 13-year-old girl</u> accused a Charlotte man, more than twice her age, of having a sexual relationship with her.

According to a search warrant released by the Charlotte-Mecklenburg Police Department, officers were called to a home on November 23 when a young girl returned home from a night out.

The girl, 13, reportedly refused to tell her parents where she had been the previous night.

When police showed up, the young girl admitted she had spent the night at the home of a 28-year-old man, with whom she has been in a year-long sexual relationship.

The young girl described the inside of **Jonathan Rubio**'s English Hills Drive apartment to officers, according to the warrant, including his bedroom.

She was then taken to a Charlotte-area hospital, by her parents, for treatment and a sexual assault kit.

Officers interviewed Rubio who said he spent the previous night with his roommate.

According go the warrant, his roommate didn't have the same story and told officers he hadn't seen Rubio most of the night.

When questioned about the girl's story about an alleged sexual relationship, Rubio wanted to leave the interview, the warrant states.

He was arrested and charged with statutory rape and indecent liberties with a child.

Rubio is currently being held in the Mecklenburg County Jail under a \$75,000 bond and a detainer from the U.S. Immigration and Customs Enforcement.

2. Drug Suspect Charged With Sexually Exploiting Minor

New felony sex charges have been levied against an illegal immigrant and suspected drug trafficker who has been behind bars since mid-October.

Hector Fuentes Gonzalez, 54, of West Church Street, Angier, was arrested Oct. 17 on felony cocaine trafficking charges.

Thanks to an extensive investigation by local and federal agents, he has been implicated on <u>charges of</u> <u>sexually exploiting a 13-year-old girl.</u>

Harnett County Sheriff's officials have formally charged the suspect with three felony counts of seconddegree sexual exploitation of a minor and one felonious count of taking indecent liberties with a minor.

The subsequent sex charges tacked on Tuesday stem from an investigation that ensued following his arrest Oct. 17 inside the suspect's residence.

Agents from the Harnett County Sheriff's Office's Narcotics Division, along with agents from Homeland Security and officials from the Angier Police Department, executed a search warranty at the West Church Street residence. An electronic device belonging to the suspect was seized during the execution. Reports indicate images captured on the device implicated the suspect.

Sheriff's Detective Brad Byrd discovered nude images of an unknown female.

After an extensive investigation, Detective Byrd — a member of the national U.S. Department of Justice's organization, Internet Crimes Against Children Task Force — discovered the girl was only 13 years of age.

It has since been determined that Gonzalez is an illegal immigrant.
