- 5.** WAKE FOREST — Wake County sheriff's deputies charged a man with five counts of sexual exploitation Monday night, saying that he sent five child-pornography video files to a Cary police detective.

**Carlos Lazaro Rivero**, 52, was arrested at his home at 428 Longbourn Drive, records show.

Arrest warrants that carried five counts of second-degree sexual exploitation of a minor said that between July 8 and last Friday, Rivero had sent video files to Detective Kevin West of the Cary Police Department.

West is assigned to fighting Internet child pornography.

Investigators estimated that the girls shown in the videos ranged from 1-3 years old to 11-13 years old, the warrants alleged.

Rivero was being held on \$400,000 bail.

Smithfield- A man in the Johnston County town of Wilson's Mills was arrested Tuesday in connection with sex offenses against a child that allegedly occurred over a six-year period.

**Miguel B. Ramirez**, 50, of 62 Rocks Edge Lane, was jailed under a \$350,000 bond on a [charge of sex offense with a child](#), according to Wilson's Mills Police Chief David Hess.

Chief Hess said the sexual abuse allegedly began when the victim was six years old and continued for the next six years. When the investigation began, police say the child moved out of Ramirez's home to live with a family member.

Police say that during the time of alleged sexual offense, Ramirez was a foster parent of the victim and later adopted the victim. Police say that at the time of the adoption the allegation of sexual abuse had not occurred and the adoption agency likely was not aware of the alleged sexual abuse to the victim.

Police began investigating Ramirez in February 2013 and arrested him after receiving help from the Selma Police Department, Department of Child Protective Services, the State Bureau of Investigation and the Johnston County District Attorney's Office.

**Gaudencio Tetlactle Chahua**, 23, of 5270 Indiana Ave., was arrested on the charge and placed in the Forsyth County Detention Center, court records show.

The warrant alleges the rape of the child took place July 31, 2013. [The child was listed as being under 13.](#)

Chahua was described in court records as a flight risk. His bond was set at \$800,000.

A Raeford man faces child sex charges after he allegedly got an 11-year-old girl pregnant, the Hoke County Sheriff's Office said Tuesday.

**Victor Miguel Ramirez**, 33, was arrested Saturday after authorities were called to Scotland Memorial Hospital in Raeford about the child, investigators said.

Ramirez was jailed under a \$1 million bond on two counts of first-degree statutory rape.

Authorities have not said how Ramirez knows the child or how long the girl has been pregnant, saying only that the alleged crimes happened between May 1 and Dec. 20.
